# GOVERNMENT OF INDIA MINISTRY OF SOCIAL JUSTICE AND EMPOWERMENT LOK SABHA

#### SOCIAL SECURITY PENSION

1945. SHRI MANISH TEWARI:

Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:

- (a) total number of beneficiaries receiving social security pensions under various schemes for women, older persons and Persons with Disabilities (PwDs) in UT, Chandigarh;
- (b) the scheme-wise pension amount provided to each beneficiary among women, the older persons and PwDs in Chandigarh;
- (c) the details of pension amount given per beneficiary under various schemes for women, older persons and PwDs in the State of Punjab and Haryana separately;
- (d) the time by which the pension amount last revised for beneficiaries in UT-Chandigarh;
- (e) whether the Union Government has received any representation from the UT Administration for an increase in the pension amount, if so, the details thereof; and
- (f) whether the Government has any plans to increase the pension amount for beneficiaries in UT-Chandigarh, if so, the details thereof, if not, the reasons therefor?

#### **ANSWER**

### MINISTER OF STATE FOR SOCIAL JUSTICE AND EMPOWERMENT (SHRI B.L.VERMA)

(a): Ministry of Rural Development, Government of India implements National Social Assistance Programme (NSAP) which is a social security programme for the most vulnerable persons of our society living below poverty line, both in rural and urban areas irrespective of the category of the beneficiaries. Under the programme, the old aged, widows, and disabled persons belonging to Below Poverty Line (BPL) and fulfilling eligibility criteria prescribed in the NSAP guidelines, are provided financial assistance, in form of pension, ranging from Rs.200/- to Rs.500/- per month and in the case of death of the breadwinner of such family, a lump sum assistance of Rs. 20,000/- is given to the bereaved family.

(b): NSAP is a 100% funded centrally sponsored scheme (CSS) covering persons belonging to families living below poverty line (BPL). It comprises of the following five schemes:

- o National Old Age Pension Scheme assistance of ₹ 200/- per month to persons in the age group of 60-79 years and ₹ 500/- per month to persons of 80 years and above. Currently, more than 221 lakh beneficiaries are covered.
- o National Widow Pension Scheme assistance of ₹300/- per month to widows in the age-group of 40-79 years and ₹ 500/- per month to widows of 80 years and above. Currently, more than 67 lakh beneficiaries are covered.
- o National Disability Pension Scheme assistance of ₹300/- per month to persons aged 18-79 years with severe or multiple disabilities and ₹ 500/- per month to persons of 80 years and above. Currently, more than 8.8 lakh beneficiaries are covered.
- o National Family Benefit Scheme -a one-time assistance of ₹ 20,000/- on the death of primary breadwinner aged between 18 and 59 years. It is a demand-based scheme. The upper limit of households is 3.58 lakh.
- o Annapurna Scheme -10 kg of food grains per month free of cost to those senior citizens who, though eligible, are not receiving old age pension. It is a demand-based scheme. The upper limit of beneficiaries is 8.32 lakh.

(c): Amount of pension under NSAP is same in all States/UTs. At present, the States/UTs are adding Top-up amounts ranging from Rs.50/- to Rs.3716/- per month per beneficiaries under NSAP schemes, resulting in an average monthly pension of around ₹1,000/- in most of the States/UTs.
