ELECTRIC VEHICLE PROMOTION AND CHARGING INFRASTRUCTURE UNDER FAME II IN ANDHRA PRADESH

1978. SHRI SRIBHARAT MATHUKUMILLI: SHRI LAVU SRI KRISHNA DEVARAYALU:

Will the Minister of HEAVY INDUSTRIES be pleased to state:

(a) the details of Original Equipment Manufacturers (OEMs) and dealers registered under the FAME II scheme in Andhra Pradesh;

(b) the total number of electric two-wheelers (e-2W), three-wheelers (e-3W) and four-wheelers(e-4W) sold under FAME II in Andhra Pradesh, district-wise, including Visakhapatnam;

(c) the total number of charging stations sanctioned under FAME II in Andhra Pradesh, along with the number of stations that have been set up, district-wise, including Visakhapatnam;

(d) whether there have been any challenges or delays in setting up charging stations in Andhra Pradesh and if so, the reasons for the delays and the expected time of completion; and

(e) the initial targets for the number of electric vehicles to be supported under FAME II and the progress made towards achieving these targets so far?

ANSWER THE MINISTER OF STATE FOR HEAVY INDUSTRIES (SHRI BHUPATHIRAJU SRINIVASA VARMA)

(a): Under the FAME-II scheme which ended on 31st March, 2024, OEMs were registered and not the dealers. No OEM was registered from the state of Andhra Pradesh under FAME-II scheme.

(c): Under FAME-II scheme, the Ministry of Heavy Industries (MHI) had initially, sanctioned, ₹800 crore-capital subsidy to three oil-marketing companies (IOCL, BPCL and HPCL) for setting up public charging stations at their Retail Outlets (ROs) across the country. Subsequently, an additional ₹73.50 crore was sanctioned for the upgradation of 980 public fast charging stations.
