Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) the details of the mangrove cover in the country, State and year-wise since 2021;
- (b) the details of the States that have successfully mapped and delineated their target intervention areas under MISHTI (Mangrove Initiative for Shoreline Habitats and Tangible Incomes) programme;
- (c) the details of the area under mangroves identified for restoration, State-wise, especially from the State of Andhra Pradesh; and
- (d) whether any States have initiated mangrove plantation or restoration, if so, the details thereof?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE (SHRI KIRTI VARDHAN SINGH)

- (a) The details of the mangrove cover in the country, State and year-wise since 2021, as per the India State of Forest Report (ISFR) 2023, is detailed in **Annexure-1**.
- (b) to (d) Implementation of Mangrove Initiative for Shoreline Habitats and Tangible Incomes (MISHTI) programme commenced in the Financial Year 2023-24 with the objective of restoration of degraded mangroves, funded by Compensatory Afforestation Fund Management and Planning Authority (CAMPA). The programme is implemented in convergence with schemes such as Mahatma Gandhi National Rural Employment Guarantee Scheme MGNREGS, and other State specific schemes/programmes. Under the programme, 06 States/UT including Andhra Pradesh submitted their plans for taking up the activities *viz* mapping, delineation, nursery creation, eco-restoration etc. and funds were released through National Authority CAMPA in FY 2024-25. The State wise details of area proposed and funds released from CAMPA under MISHTI programme are detailed in **Annexure-2**.
