Will the Minister of RAILWAYS be pleased to state:

- (a) the number of MSMEs registered as vendors for the Railways for Andhra Pradesh especially Bapatla Parliamentary Constituency and the new additions in the last year, State and district-wise;
- (b) the amount of goods procured from the said MSMEs during the last five years, Sector and year-wise;
- (c) the value of the goods procured from MSME vendors during the last five years, Sector and year-wise; and
- (d) whether there exists a procurement policy from MSMEs and if so, the details thereof and if not, the reasons therefor?

(a) and (b): The number of MSME vendors registered with Railways in Andhra Pradesh is 884, with 142 new additions in last year. The number of MSME vendors registered with Railways from area situated in Bapatla Parliamentary Constituency is 17, with 6 new additions in last year.
