NATIONAL HIGHWAYS FEE (DETERMINATION OF RATES AND COLLECTION) RULES, 2008

2315. SHRI K C VENUGOPAL:

Will the Minister of ROAD TRANSPORT AND HIGHWAYS

सड़क परिवहन और राजमार्ग मंत्री

be pleased to state:

- (a) whether there is any plan to amend the National Highways Fee (Determination of Rates and Collection) Rules, 2008, to address concerns related to toll rates, exemptions or collection mechanisms, if so, the details thereof;
- (b) the total toll collection across National Highways (NHs) in the last five years and the manner in which this revenue has been utilized for infrastructure development and maintenance;
- (c) the actions that have been taken to ensure the completion of pending works such as underpasses, service roads, and drainage systems on toll roads as per the agreement with contractors;
- (d) the penalties that have been imposed on toll contractors for noncompliance with contractual obligations and the total amount actually recovered from them so far; and
- (e) whether there are any monitoring mechanisms in place to ensure that toll contractors complete all mandated infrastructure works on time and if so, the steps taken against repeated violations?

ANSWER

THE MINISTER OF ROAD TRANSPORT AND HIGHWAYS

(SHRI NITIN JAIRAM GADKARI)

- (a) Government is working to address various issues pertaining to the levy of user fee and to enhance operational efficiency and promote convenience of the road user at Fee Plaza.
- (b) The year-wise user fee collection at fee plazas on the National Highways during the last five (05) Years are as under:

Financial Year	User fee collection (In Crore Rupees)
2019-20	27,503.86
2020-21	27,926.66
2021-22	33,928.67
2022-23	48,032.40
2023-24	55,882.13

Further, the revenue collected by the Government from user fee collection is deposited in Consolidated Fund of India (CFI) and the funds provided through budgetary allocations are utilised for the development of National Highways.

(c) The Contract Agreement with user fee collecting agencies are entered into for collection of user fee and maintenance of adjacent toilet blocks.

Other construction works viz. Highways, underpasses, service roads and drainage work, are undertaken through separate contract agreements with individual civil works contractors, in accordance with the terms and conditions specified in the respective concession/contract agreements. There is no role of user fee collecting agencies for the construction work under Public Funded highway sections. However, user fee collection starts after the substantial completion of the Projects.

- (d) The details of penalties imposed on user fee collecting contractors in the last 02 years, for breach of Contractual Obligations, are at Annexure.
- (e) Same as outlined in the reply to part (c) of this question.
