USER DEVELOPMENT FEE

2317. PROF SOUGATA RAY Will the Minister of CIVIL AVIATION

be pleased to state:-

(a) whether the Government is aware of the fact that the passengers are charged huge amount as User Development Fee by airport operators across the country;

(b) if so, the details of the fee charged, airport and operator-wise;

(c) the details of the criteria to fix User Development Fee;

(d) whether it is true that the Operators obtained the prior necessary approval from Airport Economic Regulatory Authority (AERA) in this regard and if so, the details thereof;

(e) whether the AERA/Government has permitted to charge extra charges for selection of seats in the flights other than ticket charges and if so, the details thereof; and

(f) if not, the steps taken by the Government to stop such illegal charges?

ANSWER

Minister of State in the Ministry of CIVIL AVIATION (Shri Murlidhar Mohol)

(a) to (c): Government of India has set up an Independent Economic Regulator namely, Airports Economic Regulatory Authority of India (AERA) under the AERA Act, 2008. AERA determines aeronautical charges of all the major airports such as landing, parking and User Development Fee (UDF) inter-alia considering the factors such as Return on Investment for aeronautical assets, Operating expenditure, Depreciation,Tax, etc. AERA aims to optimally balance the interest of service provider and the end user and ensures that the airport operator maintains and operates the airport with reasonable return on investment consisting with risk profile by following the statute provisions and tariff guidelines which protects the interests of Airport Operator, Airlines and passengers, at large.;

- The UDF as approved by AERA for Major Airports in FY 2024-25 is at Annexure.;

For non major airports, UDF is approved by Ministry of Civil Aviation. These are categorised into three categories, namely Cluster-1 (passenger throughput of more than 1 million passenger per annum (mppa)), Cluster-2 (passenger throughput of 0.1 mppa to 1 mppa) and Cluster-3 (passenger throughput of less than 0.1 mppa). Details of UDF at non-major airports during FY 2024-25 is as under:;

(d): Tariff for Aeronautical services is determined by AERA based on Multi Year Tariff Proposal submitted by the Airport Operators, which comes into effect after getting notified through Aeronautical Information Circular issued by Directorate General of Civil Aviation (DGCA).

(e) & (f): DGCA has issued Air Transport Circular (ATC) 01 of 2024 titled, "Unbundle of Services and fees by scheduled airlines" as per which, some services like preferential seating have been allowed to be unbundled and charged separately from the travellers. Such unbundled services are provided on "opt-in" basis by Airlines and are not mandatory in nature. Further, there is also a provision for auto seat assignment to the passengers who have not selected any seat for web check-in before scheduled departure. Scheduled domestic airlines are not charging any fee for completing web check-in formalities.
