ALLOCATION OF FUNDS TO TAMIL NADU

2319 SHRI S JAGATHRATCHAKAN:

Will the Minister of *FOOD PROCESSING INDUSTRIES* be pleased to state:

- (a) whether it is a fact that around 10% of food is only processed in India and if so, the details thereof:
- (b) the details of fund allocation to Tamil Nadu under various schemes for the last five years till date, year-wise;
- (c) the details of employment opportunities created in food processing sectors under various programmes including PMFME in the country during the last three years, State-wise;
- (d) the details of Self-Help Groups, Women entrepreneurs benefited under the Scheme during the last three years in Tamil Nadu, State/District wise;
- (e) the steps taken by the Government to strengthen and extend financial support particularly in the Delta region of Tamil Nadu; and
- (f) whether the Government has taken any steps to increase the formal sector in Food processing and achievements made so far if so, the details thereof?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI RAVNEET SINGH)

- (a): As per the report of the "Study to determine level of Food Processing in India" in 2021 commissioned by Ministry of Food Processing Industries (MoFPI), the details of the extent of processing of agricultural commodities covered in the study are placed at **Annexure-I**.
- (b): MoFPI implements Central Sector Umbrella Scheme, Pradhan Mantri Kisan Sampada Yojana (PMKSY), since 2016-17, Production Linked Incentive Scheme for Food Processing Industry (PLISFPI), since 2021-22 and Centrally sponsored Pradhan Mantri Formalization of Micro Food Processing Enterprises (PMFME) Scheme, since 2020-21. PMKSY is demand driven in nature and applications are invited through Expression of Interest (EoI) from all over India. The funds are not allocated/sanctioned/released state-wise under any of the component schemes of PMKSY. The details of number of projects approved and completed/operational in the state of Tamil-Nadu since inception of PMKSY is placed at **Annexure-II**.

Under PLISFPI, incentives are granted directly to the beneficiary company and not through the state Government. Under PMFME, Centre Share amount of Rs. 212.19 Cr. has been

released for implementation of various components of the Scheme for the state of Tamil Nadu. The year-wise details are mentioned below:

- (c): The details of state-wise employment generated under PMKSY and PMFME scheme of MoFPI for the last three years is placed as **Annexure-III.** Under PLISFPI, the total employment of 3,31,018 has reportedly been generated.
- (d): Under the PMFME scheme, support for Credit Linked Subsidy is being provided for setting up of new/ upgradation of existing micro food processing enterprises. During the last three years, for the State of Tamil Nadu, 8377 Loans have been sanctioned for women entrepreneurs and 11 for Self Help Groups under Credit Linked Subsidy as on 28th February, 2025. In addition to this, Seed capital support @ Rs. 40,000 is being provided to SHG members. During the last three years, 22,053 SHG members have been sanctioned for Seed capital in the state of Tamil Nadu. The District-wise year-wise details for the State of Tamil Nadu is at **Annexure IV**.
- (e): In order to promote food processing sector in the country, Ministry of Food Processing Industries (MoFPI) has been incentivizing setting up/expansion of food processing units and related infrastructure through its Central Sector Scheme Pradhan Mantri Kisan SAMPADA Yojana (PMKSY), Production Linked Incentive Scheme for Food Processing Industry (PLISFPI) and Centrally Sponsored PM Formalization of Micro Food Processing Enterprises (PMFME) Scheme. These schemes are not region or state specific but demand driven. Ministry extends financial support to prospective entrepreneurs for setting up of different kinds of food processing units including prospective entrepreneurs from Delta region of Tamil Nadu state as per respective scheme guidelines
- (f): The PMFME scheme aims to enhance the competitiveness of existing individual microenterprises in the unorganized segment of the food processing industry and promote formalization of the sector. The scheme provides support of credit-linked grant of 35% of the eligible project cost, seed capital of up to Rs. 40,000, capacity building for beneficiaries, and handholding support for the formalization of units. Formalization of units is facilitated through Udyam Aadhaar registration, FSSAI registration, GST registration as per the applicability through handholding support by District Resource Person (DRPs). Under the PMFME Scheme, 36,946 enterprises have been formalized till 28th February 2025.
