PROPOSALS UNDER PM-JANMAN IN ANDHRA PRADESH

2374. Dr. Byreddy Shabari:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) the population of Particularly Vulnerable Tribal Groups (PVTGs) in Andhra Pradesh, district-wise;
- (b) the number of proposals received under the Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PM-JANMAN) from Andhra Pradesh, scheme and component-wise;
- (c) the target set and the achievement made under each scheme and component of PM-JANMAN in Andhra Pradesh, district-wise;
- (d) the status of the said proposals, project-wise including pending, ongoing and completed projects with a specific focus on Nandyal district;
- (e) the total funds allocated, released and utilized for these projects in Andhra Pradesh, particularly in Nandyal district; and
- (f) whether the Government has identified any challenges in the implementation of PM-JANMAN in Andhra Pradesh and if so, the details thereof along with the steps taken/being taken to address them?

ANSWER

MINISTER OF STATE FOR TRIBAL AFFAIRS (SHRI DURGADAS UIKEY)

- (a) Ministry of Tribal Affairs through the State Governments/ UT Administration/departments has undertaken habitation level data collection exercise through PM Gati Shakti mobile application to estimate PVTG population figures and infrastructure gaps in order to cover PVTG population residing in villages & habitations covered under PM JANMAN. Based on the data captured (as on 28.02.2025) and confirmed by State Tribal Welfare department, estimation of PVTG population in Andhra Pradesh, District-wise is at **Annexure-I**.
- (b) to (e) The details of benefits given under PM JANMAN in Andhra Pradesh including Nandyal district since its inception is as follows:
