(a) to (e): The Government had notified the "Pradhan Mantri JI-VAN (Jaiv Indhan-Vatavaran Anukool fasal awashesh Nivaran) Yojana" 2019, amended in 2024, to provide financial support for setting up Advanced Biofuels projects in the country using lignocellulosic biomass and other renewable feedstock. Under this scheme, a total of 14 commercial scale proposals and 8 demonstration scale proposals were submitted for approval, of which 8 commercial scale proposals including one from Andhra Pradesh and 4 demonstration scale proposals have been approved. Proposals are reviewed on an ongoing basis.

The State-wise and Year-wise details of commercial scale proposals and demonstration scale proposals received and approved under the scheme during the last five years along with physical and financial progress of these projects, are at **Annexure**.
