CPSE Projects Operational in West Bengal

Will the Minister of FINANCE be pleased to state:

- (a) the details of Central Public Sector Enterprises (CPSEs) projects currently operational in West Bengal;
- (b) the number of new CPSEs, extension projects approved and shut down in West Bengal during the last ten years; and
- (c) the total amount of funds allocated and utilised for the same during the last ten years?

(a) The Ministry of Statistics and Programme Implementation is mandated to monitor Ongoing Central Sector Infrastructure Projects costing ₹ 150 crore and above on time and cost overrun, based on the information reported by the Line Ministries/ Project Implementing Agencies on the Online Computerized Monitoring System (OCMS) of the Ministry. Based on the information furnished by Ministry of Statistics and Programme Implementation, the details of on-going projects of Central Public Sector Enterprises (CPSEs) in West Bengal are at Annexure-I.

(b) & (c) As per information available in PE Survey 2023-24, the number and details of new CPSEs incorporated during the last ten years with registered office in West Bengal are at Annexure-II. Most CPSEs have operations beyond the place of their incorporation.

Based on the information furnished by Ministry of Statistics and Programme Implementation, the number of completed projects and dropped /deleted projects of CPSEs along with their cost and expenditure details during the last ten years in West Bengal are at Annexure III & IV respectively.
