## REPATRIATION OF ARTEFACTS THROUGH CULTURAL PROPERTY AGREEMENT

Will the Minister of CULTURE be pleased to state:-

- (a) the number of looted or stolen artefacts which have been repatriated during the last decade from various countries;
- (b) whether any agreements is being planned for repatriation of more Indian artecrafts from foreign countries, private collectors and others, if so, the details thereof;
- (c) the number of looted or stolen artefacts that are expected to be repatriated under the Cultural Property Agreement to prevent illicit Trade of Antiquities agreement between India & USA during the last decade from various countries;
- (d) the details of the time-line for bringing them back;
- (e) whether the Government plans to collaborate with international organisations or other nations to further strengthen its efforts in recovering stolen antiquities, if so, the details thereof;
- (f) whether the agreement includes provision for enhancing bilateral cooperation in heritage conservation, museum exchanges, or technical training in cultural preservation, if so, the details thereof;
- (g) the details of the major cultural or religious places of Chhattisgarh where from artefacts have been stolen so far;
- (h) whether efforts have been made to recover these artefacts, if so, the details thereof;
- (i) whether the State Government of Chhattisgarh has taken any specific step to secure the cultural heritage and check the incidents of theft and if so, the details of the steps taken in this regard; and
- (j) whether the Government is considering opening up of more Archaeological and religious sites for workshop, if so, the details thereof, if not, the reasons therefor?

#### **ANSWER**

# MINISTER OF CULTURE AND TOURISM (SHRI GAJENDRA SINGH SHEKHAWAT)

- (a) Total 642 antiquities have been retrieved from various countries during the last decade.
- (b to (d) No such agreement is under consideration; however, a Cultural Property Agreement (CPA) has been signed with the United States of America (USA) to prevent smuggling of Indian antiquities. Agreement, being preventive in nature, no such numbers has been targeted.
- (e) India collaborates with different International organisations including UNESCO and INTERPOL as per requirement.
- (f) The CPA has provision for fostering cooperation and mutual understanding in the matters of technical assistant, illicit trade and pillage of Cultural property.
- (g) Total 27 antiquities have been stolen from Chhattisgarh as detailed in 'Annexure A'.
- (h & i) Archaeological Survey of India is committed for protection of monuments, sites and antiquities under its jurisdiction. Besides regular watch and ward staff of Archaeological Survey of India, Private Security Guards and Central Industrial Security Force have been deployed as per requirement. Whenever any theft of antiquity is reported, FIR is lodged in concerned police station and 'Look Out Notice' is issued to law enforcement agencies including Custom Exit Channels to keep vigil to trace stolen antiquity and prevent its illegal export.
- (j) No such proposal is under consideration.
