- (a) the details of the projects approved/sanctioned/executed for the development of tourism in Maharashtra particularly in Parbhani and Osmanabad Parliamentary Constituencies during the last three years and the current year, year-wise;
- (b) the details of tourism projects completed so far and the time by which the remaining projects are likely to be completed;
- (c) the reasons for delay in completion of pending projects and whether the Government has conducted any inquiry into it, if so, the details thereof;
- (d) the details of the funds allocated/released/utilised for the development of tourism sector in the State during the said period, year-wise;
- (e) whether the State Government of Maharashtra has submitted any proposal to the Government; and
- (f) if so, the details thereof and the present status of the ongoing projects in Maharashtra?

ANSWER

(a) to (f): Development and promotion of tourist destinations and products is primarily undertaken by the respective State Governments/Union Territory (UT) Administrations. The Ministry of Tourism complements these efforts of States/UTs by developing and promoting various tourism products of the country, including in Maharashtra through various schemes and initiatives.

The Ministry of Tourism through its central sector schemes of 'Swadesh Darshan (SD)', 'Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' and 'Assistance to Central Agencies for Tourism

Infrastructure Development' extends financial assistance to the State Governments/UT Administrations/Central Agencies including the State of Maharashtra.

Ministry of Tourism has revamped Swadesh Darshan Scheme as Swadesh Darshan 2.0 (SD2.0) with the objective to develop sustainable and responsible tourism destinations following a destination & tourist centric approach.

The Government of India under the guidelines for Special Assistance to States/Union Territories for Capital Investment (SASCI) for Development of Iconic Tourist Centres has approved two projects in the State of Maharashtra.

Details of projects sanctioned under the aforesaid schemes for the State of Maharashtra are Annexed.

The projects sanctioned under the above schemes are implemented by respective State Governments/UT Administrations/Central Agencies. Ministry of Tourism monitors the progress of projects from time to time and also encourages respective State Government/UT Administrations/Central Agencies to complete the projects in a time bound manner.

Receiving proposals from the State Governments/UT Administrations/Central Agencies for financial assistance for tourism projects is a continuous process. The proposals received are examined with reference to the prescribed guidelines and financial assistance is extended for such projects subject to fulfillment of the stipulated conditions and availability of funds.
