### KENDRIYA VIDYALAYAS IN UTTAR PRADESH

Will the Minister of EDUCATION be pleased to state:

- (a) the details of steps taken to promote quality education and to meet the increasing demand for admission in Kendriya Vidyalayas in Uttar Pradesh;
- (b) the details of steps taken for expansion of Kendriya Vidyalayas in Fatehpur district of Uttar Pradesh;
- (c) the amount of funds allocated for the construction of building of said Kendriya Vidyalaya along with names of agencies/institutions engaged for construction work of the same; and
- (d) the time by which construction of the new school campus/building of Kendriya Vidyalaya Andoli, Madhupuri in Fatehpur district, Uttar Pradesh is likely get completed?

### ANSWER

# MINISTER OF STATE IN THE MINISTRY OF EDUCATION (SHRI JAYANT CHAUDHARY)

(a) Kendriya Vidyalayas (KVs) provide quality education to the children admitted across the country including KVs in the state of Uttar Pradesh. Recruitment of qualified teachers, robust capacity building of teachers both in-house and with knowledge partners of Kendriya Vidyalaya Sangathan (KVS), three tier academic monitoring of KVs at school, regional and headquarter level, using technology in teaching by teachers for making joyful and interesting, using child centered pedagogy, adopting competency based learning and assessment, promoting participation of students in various games and sports, NCC, scouts and guides and other competitions and programmes for holistic development of children are being undertaken to promote quality education in KVs. Further, new KVs are being opened as per demand following due procedure to meet the increasing demand for admission in KVs in Uttar Pradesh.

(b) Opening of new KVs is a continuous process. KVs are opened primarily to cater to the educational needs of the wards of transferable Central Government Employees including Defence & Para-military personnel, Central Autonomous Bodies, Central Public Sector Undertakings (PSUs) and Central Institute of Higher Learning (IHL) by providing a common programme of education throughout the country. Proposals for opening of new KVs may be sponsored by Ministries or Departments of the Government of India / State Governments / Union Territories (UTs) Administrations, with commitment to provide requisite resources including land and temporary accommodation for setting up a new KV as per norms. The proposals are subject to approval of the competent authority as per extant procedures. At present, 122 KVs including 01 KV at Madhupuri is functioning in Fatehpur district of Uttar Pradesh.

As per information received from Kendriya Vidyalaya Sangathan (KVS), no proposal for opening of new KV at Fatehpur district of Uttar Pradesh has been received by KVS from the concerned State Government / district administration.

(c) & (d) KVS has accorded approval of Rs. 2460.34 lakh and fund of Rs. 1820.00 lakh has been released so far to construction agency Central Public Works Department. Construction of permanent buildings for KVs is a continuous process, which depends upon identification of suitable land, completion of transfer / lease formalities in favour of KVS by the sponsoring authorities, submission of drawings / estimates by construction agency, availability of funds and requisite approvals etc.
