## BHARAT CAMPAIGN FOR AGRICULTURE INFRASTRUCTURE PROJECTS

2837. SMT. DELKAR KALABEN MOHANBHAI:

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

(a) whether the Government has launched Banks Heralding Accelerated Rural and Agriculture Transformation (BHARAT) campaign to create a competitive environment among banks and lending institutions to provide timely credit for agriculture infrastructure projects in the country including the Union Territory of Dadra and Nagar Haveli;

(b) if so, the likely benefits to this scheme is to be provided to the agriculture sector; and

(c) the details thereof, State-wise including the Union Territory of Dadra and Nagar Haveli?

## ANSWER

MINISTER OF STATE FOR AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण राज्य मंत्री (SHRI RAMNATH THAKUR)

(a) to (c): Yes, Sir. A campaign named 'BHARAT' (Banks Heralding Accelerated Rural & Agriculture Transformation) has been launched by the Government under Agriculture Infrastructure Fund Scheme to provide maximum benefits to the people and to create a competitive spirit among the Banks and lending institutions to mobilize agriculture infrastructure projects loan at a faster pace. The Campaign was launched from 15<sup>th</sup> July 2023 to 31<sup>st</sup> August 2023 all over India including the Union Territory of Dadra and Nagar Haveli with an overall target of Rs 7200 Crore. Top performing Banks under different categories i.e. commercial Banks in public and private Sector, Regional Rural Banks, Small Finance Banks (SFBs), Non-Banking Financial Companies (NBFCs) and cooperative Banks were selected at the end of the Campaign and their special contribution was recognized. During the campaign, a total of Rs 4,856 Crore was sanctioned by various banks for the establishment of 5,256 infrastructure units across different regions of the country, focusing on the agricultural sector.

The purpose of the campaign was to foster a competitive environment among banks and lending institutions. To achieve this, specific targets were assigned to these banks and lending institutions. During the BHARAT campaign no project was sanctioned in the Union Territory of Dadra and Nagar Haveli.
