#### PENDING APPLICATION UNDER PMAY-G OF JHARKHAND

### 2953. SHRI CHANDRA PRAKASH CHOUDHARY:

## Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the details of total funds spent on the Pradhan MantriAwaasYojana-Gramin (PMAY-G) since its inception, State-wise;
- (b) the number of homes allotted to beneficiaries in Jharkhand under PMAY-G since its inception, State and district-wise;
- (c) the number of applications that are currently pending under PMAY-G in Jharkhand, State and district-wise; and
- (d) the total amount of funds allocated to the PMAY-G that could not be utilized within the time frame, State and district-wise?

### **ANSWER**

# MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (DR.CHANDRA SEKHAR PEMMASANI)

- (a): In order to achieve the objective of "Housing for All" in rural areas, the Ministry of Rural Development is implementing Pradhan MantriAwaasYojana- Gramin (PMAY-G) with effect from 1st April 2016 to provide assistance to 4.95 crore eligible rural households with basic amenities by March 2029. As on 12.03.2025, a cumulative target of 3.79 crore houses have been allotted to States/UTs out of which 3.56 crore houses have been sanctioned and 2.72 crore houses have been completed. The details of Central share released by the Ministry and funds utilized by the States/UTs since inception of the scheme is 2016-17 to 2024-25 till 12.03.2025 is given in Annexure-I.
- (b): The Ministry allocates targets to the States and further allocation of targets to the Districts/ Blocks/ Gram Panchayats is done by the respective State Governments. The details of district-

wise targets allocated by the State of Jharkhand is given in Annexure-II.

(c): No application from households is required under PMAY-G as the beneficiaries are identified from the Permanent Wait List (PWL) of PMAY-G based on SECC 2011 and finalisedAwaas+, 2018 list. Further, The Union Cabinet has approved the continuation of PMAY-G till March, 2029 for construction of 2 crore more houses.

The Government of India has approved the conduct of exercise for updating the Awaas + 2018 list for identifying additional eligible rural households for getting benefits under the scheme using modified exclusion criteria. In line with the approval of the Government of India, a survey is being conducted for the identification of additional eligible rural households under the scheme. The survey is being conducted through Awaas + 2024 Mobile App which has been launched on 17.09.2024. The App has provision for both self survey and assisted survey through preregistered surveyors. The survey began with the registration of surveyors by the States/UTs. Thereafter, Awaas+ 2024 household survey has also started from 27.12.2024. The initial deadline for completion of the Awaas+ 2024 survey is 31.03.2025.

(d): The Central Assistance under PMAY-G is released directly to the State/UT considering the State/UT as a unit. Further release of these funds to beneficiaries in various districts is done by the respective State/UT Governments. The details of Central share released by the Ministry and funds utilized by the States since inception of the scheme is 2016-17 to 2024-25 till 12.03.2025 is given in Annexure-I.
