BAMBOO CULTIVATION IN ASSAM

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

(a) whether the Government has data on the expansion of bamboo cultivation in Assam;

(b) if so, the details thereof and its subsequent impact on the rural livelihoods;

(c) whether dedicated initiatives have been launched to promote bamboo-based industries, including financial and technical support for artisans and entrepreneurs, if so, the details thereof; and

(d) the steps being taken to expand domestic and international markets for Assam's bamboo products?

ANSWER

(a) & (b): Under the restructured National Bamboo Mission (NBM), 10 Nos. of bamboo nurseries have been established in Assam since 2018-19 for raising quality planting materials, through which the sapling production capacity has increased to 2.5 lakh per annum. Since then, an area of 1856 ha has been brought under bamboo cultivation in the state. Further, the total bamboo-bearing area of Assam in recorded forests has increased from 10,659 sq. km in 2021 to 11246 sq. km in 2023.

(c) & (d): The restructured NBM, a Centrally Sponsored Scheme focuses on the development of a complete bamboo value chain to link growers with consumers, starting from planting material, plantation, and creation of facilities for collection, aggregation, processing, marketing, and brand-building initiatives. Financial assistance and technical support are provided to the farmers, artisans, and entrepreneurs. The pattern of assistance for establishing bamboo based value addition units under NBM is given at Annexure I.

A dedicated page for bamboo products has been created on the GeM portal for marketing bamboo products. Further, the State Bamboo Missions, including Assam, are organizing awareness campaigns, seminars, workshops, bamboo fests and trade fairs to support the artisans and entrepreneurs in expanding the market for their products.
