(a) to (e) The 70th National Film Awards (NFA) presentation ceremony was organized by the Ministry of Information & Broadcasting on 08.10.2024 at Vigyan Bhawan, New Delhi. The gazette notification of the 70th NFA winners and the regulations are available on the website https://mib.gov.in/documents/notification/Other-communication.

The primary responsibility of promotion and development of tourism, including film tourism, is of the respective State Governments/ Union Territory (UT) Administrations. However, Ministry of Tourism, complements the efforts of States/ UTs by developing and promoting various tourism products of the country, including Film Tourism through various schemes and initiatives.

Further, in order to attract more foreign film production in the country and to promote India as favorable shooting destination, the Government of India had introduced the incentive scheme in 2022, this was further enhanced in 2023. The scheme offers up to 40% reimbursement of the Qualified Production Expenditure to Foreign productions and official coproductions. There has been a consistent increase in the foreign film shooting permission and official co-productions as per Annexure.
