SCHEMES FUNDED BY HUDCO

NO. 3247. SHRI OMPRAKASH BHUPALSINH ALIAS PAVAN RAJENIMBALKAR: SHRI ARVIND GANPAT SAWANT:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) whether the loans are provided by the Housing and Urban Development Corporation Limited (HUDCO) to needy persons under various schemes and if so, the provisions and criteria thereof;
- (b) the number of schemes financed by HUDCO during the last five years and the current year, State-wise, particularly district-wise for Maharashtra;
- (c) whether some schemes financed by HUDCO were not approved by certain State Governments during the said period;
- (d) if so, the details thereof and the steps taken by the Government to make HUDCO-financed schemes more viable for States;
- (e) whether a large number of States have sought assistance from HUDCO for housing construction and if so, the details thereof, State-wise, particularly district-wise for Maharashtra along with HUDCO's response thereto;
- (f) whether the Government proposes any special schemes under this initiative for aspirational districts and if so, the details thereof, district-wise, particularly for Osmanabad Parliamentary Constituency; and
- (g) the steps taken by the Government to enhance HUDCO's resource base and expand its operations during the current financial year?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI TOKHAN SAHU)

- (a) HUDCO is a financial institution which provides loan assistance for Housing and Infrastructure projects of various State Government Agencies for implementation of Central Government and State Government schemes, which in turn caters to various socio-economic groups including needy persons. However, as of today, HUDCO does not directly provide loan assistance to individuals under project loans. HUDCO used to provide individual housing loans under HUDCO Niwas retail finance scheme, which is currently not in operation.
- (b) Number of schemes sanctioned by HUDCO in last five years is enclosed at Annexure 1. Number of schemes in Maharashtra State is enclosed at Annexure 2.
- (c) & (d) HUDCO extends financial support for projects being taken up by various State Agencies / Parastatal agencies which are approved by State Government in line with Policies of State Government.
 - (e) State Government agencies are availing financial assistance from HUDCO for Viability Gap Funding in Central Government Flagship programmes and for availing loan assistance in schemes pertaining to construction of houses. Number of housing schemes sanctioned in last five years is enclosed at Annexure 3. There are no specific schemes sanctioned exclusively for Housing in Maharashtra during the last 5 years.
 - (f) HUDCO sanctions schemes on receiving loan applications along with projects details including statutory clearance, State Govt. approval for the scheme/ borrowing / taking up the project, etc. by the borrowing institutions.
 - (g) HUDCO's net owned funds (NoF) as on 31.12.2024 are Rs. 17,965.59 crore, which includes equity share capital of Rs. 2001.90 crore. HUDCO's Debt Equity Ratio as on 31.12.2024 stood at 5.17 times and hence depending upon operational requirements, HUDCO would be in a position to raise resources from diversified sources at market competitive rates.
