- (b) whether the environmental clearances, financial allocations and award of contract completed in case of new oil and gas exploration blocks in the ecologically fragile Gulf of Mannar region, if so, the details thereof;
- (c) the details of the companies both Government and Private given contracts since 2014 to conduct such explorations with site details;
- (d) Whether any new oil and gas exploration projects given in the Cauvery Delta districts including Mayiladuthurai Parliamentary Constituency which covers three assembly constituencies in Thanjavur districts as well since 2024; and
- (e) if so, the details of such explorations cancelled since 2014 and the reasons therefor?

(a) The State-wise details of environmental clearances given to oil and gas exploration projects since 2014 is attached as **Annexure I**.

(b) & (c) Since 2014, No contract has been awarded to any operator in respect of exploration of any block falling in Gulf of Mannar.

(d) No new oil and gas exploration projects have been undertaken in the Cauvery Delta Districts including Mayiladuthurai Parliamentary Constituency which covers three assembly constituencies in Thanjavur districts as well since 2024.

(e) Two exploration blocks, namely CY-ONHP-2017/1 (Onland) and CY-ONHP-2018/2 (Onland) awarded to M/s Oil and Natural Gas Corporation Limited (ONGC) have been relinquished by the Operator due to non grant of Petroleum Exploration License (PEL) by the State Government of Tamil Nadu.
