- (a) whether the Government proposes to provide LPG gas through pipelines to those villages and towns in Uttarakhand and Rajasthan where gas is still supplied through cylinders;
- (b) if so, the details thereof;
- (c) the details of the steps taken/being taken by the Government in this regard; and
- (d) the cities of Rajasthan covered under the said plan, especially Udaipur and Chittorgarh districts?

(a) to (d): No, No such proposal to supply LPG through pipeline is currently under consideration.

Piped Natural Gas (PNG) is supplied to households by respective entities authorised by Petroleum and Natural Gas Regulatory Board (PNGRB). Providing PNG connections is a part of the development of City Gas Distribution (CGD) network and the same is carried out by the entities authorised by PNGRB as per their Minimum Work Programme (MWP). PNGRB has authorized entities for the development of CGD network in 307 Geographical Areas (GAs), including villages and towns in the states of Uttarakhand and Rajasthan, covering almost 100% of the mainland area for the development of CGD network across the country. The details of the PNG connections in the State of Uttarakhand and Rajasthan is given at Annexure.
