(a) the number of projects that are passing through Andhra Pradesh taken up under the National Gas Grid;

(b) the progress of these projects during the last five years and the current year, year-wise;

(c) the details of the funds disbursed for these projects during the last five years and the current year, year-wise and project-wise; and

(d) whether the Government has set any timeline to complete these projects, if so, the details thereof and if not, the reasons therefor?

(a) to (d):Laying of natural gas pipelines is carried out by the entities authorized by Petroleum and Natural Gas Regulatory Board (PNGRB). As of 30.09.2024, approximately 24,945 km of Natural Gas Pipeline (NGPL) network - including common carrier, spur line, tie-in connectivity, and dedicated pipeline - across the country is operational and 10,805 km of pipeline is under construction.

The details of the NGPLpassing through the state of Andhra Pradesh taken under National Gas Grid, and the timeline for completion of these projects are at **Annexure**. The funds required for development of these projects are infused by authorized entities.
