**FUNDS ALLOTTED FOR TOURISM SCHEMES IN UDAIPUR**

**+3815. DR. MANNA LAL RAWAT:**

**Will the Minister of TOURISM be pleased to state:**

- (a) the funds allocated under various schemes of the Government to Rajasthan, especially Udaipur district having rich and plentiful tourist sites and eco-tourism sites;**
- (b) the details of the projects introduced in Rajasthan to improve tourism infrastructure and promote sustainable and an approach focused on accountability;**
- (c) whether more funds would be allocated to Udaipur district under various schemes keeping in view the immense potential of tourism development in the said district; and**
- (d) if so, the details thereof?**

**ANSWER**

**THE MINISTER OF TOURISM (SHRI GAJENDRA SINGH SHEKHAWAT)**

**(a) to (d): Development and promotion of tourist destinations and products is primarily undertaken by the respective State Government/Union Territory (UT) Administration. The Ministry of Tourism through its central sector schemes of 'Swadesh Darshan (SD)', 'Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' and 'Assistance to Central Agencies for Tourism Infrastructure Development' complements the efforts of tourism infrastructure development in the country by extending financial assistance to the State Governments/UT Administrations including the State of Rajasthan.**

**Ministry has revamped Swadesh Darshan Scheme as Swadesh Darshan 2.0 (SD2.0) with the objective to develop sustainable and responsible tourism destinations following a destination & tourist centric approach.**

**The Government of India under the guidelines for Special Assistance to States for Capital Investment (SASCI) for Development of Iconic Tourist Centres has approved two projects in the State of Rajasthan.**

**Details of projects sanctioned under the aforesaid schemes for the State of Rajasthan are Annexed.**

**Receiving proposals from the State Governments/UT Administrations/Central Agencies for financial assistance for tourism projects is a continuous process. The proposals received are examined with reference to the prescribed guidelines and financial assistance is extended for such projects subject to fulfilment of the stipulated conditions and availability of funds.**
