(a) India's total exports to Bangladesh stands at USD 5807.69 Mn and imports remained at USD 1070.75 Mn during the last six months (FY Aug 2024- Jan 2025).

Top 10 Major exports as per HS classification nomenclature are mineral fuels and oils, cotton, other textile vegetable textile fibres, edible vegetables and certain roots, tubers and vehicles other than railways and tramways during last six months. (**Annexure I**)

Top 10 Major imports by India from Bangladesh as per HS classification nomenclature are articles of apparel and clothing not knitted or crocheted, apparel and clothing knitted or crocheted, other textile vegetable textile fibers, animal or vegetable fats and oils and other made-up textile articles during last six months. (**Annexure II**)

(b) There is a bilateral mechanism in place where trade related issues between India and Bangladesh are discussed on regular basis.
