(I) Component A of National Programme for Dairy Development scheme in Uttar Pradesh

8 projects were approved under NPDD scheme in Uttar Pradesh with a total outlay of Rs.9123.78 lakh (Central Share Rs.7496.00 lakh). These projects are being implemented by Pradeshik Cooperative Dairy Federation (PCDF) through Regional/District level Milk Unions. After approvals, 4 projects were completely withdrawn by the State and funds released were refunded. Till date, an amount of Rs.848.91 lakh has been utilised by Uttar Pradesh under the scheme.

Component A of NPDD scheme: Bahraich district

At a cost of Rs.1.366 lakh, 246 farmer and DCS staff have been trained under the scheme in Behraich district of Uttar Pradesh.

Component 'B' of the NPDD scheme

Under the scheme, 1 project for Shwetdhara Milk Producer Company has been approved with total outlay of Rs. 18.81 Crore (Loan: Rs. 4.88 Crore; Grant: Rs. 13.13 Crore; PI contribution of

Rs. 0.80 Crore). The sanctioned project covers Bahraich along with Pratapgarh, Jaunpur, Ambedkarnagar, Shrawasti, Balrampur.

2. Supporting Dairy Cooperatives and Farmer Producer Organizations engaged in dairy activities (SDCFPO):

The Union Cabinet has approved implementation of central sector scheme Supporting Dairy Cooperatives and Farmer Producer Organizations engaged in dairy activities (SDCFPO) as a part of Umbrella Scheme "Infrastructure Development Fund" from 2021-22 to 2025-26 with an outlay of Rs 500 Cr. i.e. Rs. 100 crore each year. Under the Component "B" of the scheme, an interest subvention of 2% per annum on the working capital loan is being provided to the producer owned Institutes (POIs.). Further, for prompt and timely repayment, an additional 2% per annum interest subvention is payable at the end of the loan repayment/interest servicing period.

Under this scheme during 2020-21, an amount of Rs 19.35 lakh as regular interest subvention were released against the working capital loan amount of Rs 26 Cr for Lucknow Milk Union. In the subsequent year no proposals were received from Lucknow milk Union.

(II) Rashtriya Gokul Mission:

- (i) Nationwide Artificial Insemination programme to enhance artificial insemination coverage and under the programmed AI services are delivered free of cost at farmers doorstep. In Bahraich district constituency 1.36 Lakh animals are covered with total number of 2.05 lakh AI done benefiting a total number of 0.94 Lakh farmers.
- (ii) Accelerated breed improvement programme to produce female calves using sex sorted semen with 90% accuracy and under the programme incentive upto 50% of the cost of sex sorted semen is made available to farmers.
- (iii) Accelerated breed improvement programme using IVF technology and under the programme incentive of Rs 5000 per assured is available to farmers.
- (iv) Training and equipping MAITRI's to deliver artificial insemination services at farmers doorsteps. A total number of 155 MAITRI's have been trained in Bahraich

- (v) Genomic chip for genomic selection to identify elite animal of indigenous breeds.
- (vi) Progeny Testing and Pedigree Selection Programme for production of High Genetic Merit bulls including indigenous breeds.
- (vii) Strengthening of semen stations for attaining quantitative and qualitative improvement in semen production.

(III) National Livestock Mission:

The Department of Animal Husbandry and Dairying, Government of India is implementing a scheme named 'National Livestock Mission (NLM)' since the financial year 2014-15. The scheme has been revised and realigned from the financial year 2021-22 and aims to create employment generation, entrepreneurship development, increase in per animal productivity and thus targeting increased production of meat, goat milk, egg and wool under the umbrella scheme Development Programme. The scheme was further modified on 21stFebruary, 2024 wherein breed-upgradation of Camel, Horse and Donkey was included along with Fodder Production from waste land/range land/degraded forest land.

The scheme has following three Sub-Missions:

- (i) Sub-mission on Breed Development of Livestock and Poultry: proposes to bring sharp focus on entrepreneurship development and breed improvement in poultry, sheep, goat and piggery by providing the incentivization to the Individual, FPOs, FCOs JLGs, SHGs, Section 8 companies for entrepreneurship development and to the State Government for breed improvement infrastructure. The Government of India provides 50% subsidy to the entrepreneurs for establishment of poultry, sheep goat, piggery, camel, horse, donkey units.
- (ii) Sub-mission on Feed and Fodder Development: This Sub-Mission aims towards strengthening of fodder seed chain to improve availability of certified fodder seed required for fodder production, encouraging entrepreneurs for establishment of fodder Block/Hay Bailing/Silage Making Units and fodder production from wasteland/ degraded forestland. Incentives are provided for production of breeder, foundation and certified seed at rate of Rs.250/Kg, Rs.150/kg and Rs.100/Kg respectively.
- (iii) Sub-mission on Innovation and Extension: The sub-mission aims to incentivize the Institutes, Universities, Organizations carrying out research and development related to sheep, goat, pig and feed and fodder sector, extension activities, livestock insurance and innovation. Assistance is provided to the central Agencies, ICAR Institutes and University farms for applied research required for development of the sector, extension services including promotional activities for animal husbandry and schemes, seminars, conferences, demonstration activities and other IEC activities for awareness generation through the state Government.
- (IV) Under the National Livestock Mission-Livestock Insurance activity, an amount of ₹7.71 crore has been released to Uttar Pradesh, covering the insurance of 3.06 lakh livestock in the current financial year. Under the Entrepreneurship Development Program, 145 projects have been approved with a total project value of ₹78.35 crore, and the approved subsidy amounts to ₹32.90 crore. So far, the Department has released ₹4.7844 crore as the first installment to 31 projects, while six projects have received the second instalment of Rs 1.015 crores since the inception if the scheme.

(IV) Livestock Health and Disease Control Programme:

Department is supporting the States/UTs through the implementation of Livestock Health & Disease Control Programme (LHDCP) scheme in all States/UTs, with the aim of reducing risk to animal health by prophylactic vaccination against diseases of animals, capacity building of Veterinary services, disease surveillance and strengthening Veterinary infrastructure, training, publicity and awareness.

- i. Under National Animal Disease Control programme (NADCP) 100%, central assistance is provided to States/UT's for Vaccination against Foot and Mouth Disease (FMD) and Brucellosis and for Vaccination against Peste des Petits Ruminants (PPR) and Classical Swine Fever (CSF) under Critical Animal Disease Control Programme (CADCP). In district Bahraich the total number of FMD vaccination: 16,15,137; total number of Brucella vaccination 928; total number of registered animals 3,38,043 and toal number of farmer benefitted: 1,33,911.
- ii. Assistance to States for Control of Animal Disease (ASCAD) under LHDCP for control of state prioritized exotic, emergent and zoonotic animal diseases.
- iii. Under the component of Establishment and Strengthening of Veterinary Hospitals and Dispensaries (ESVHD-MVU) of LHDCP, financial assistance has been provided to states/UTs and 4016 MVUs are operationalised helping in delivery of veterinary healthcare services at farmers' doorsteps in respect to disease diagnosis, treatment, vaccination, minor surgical interventions, audio-visual aids and extension services. In district Bahraich a total of 8 MVUs are operational
