Will the Minister of Panchayati Raj be pleased to state;

- (a) the details of the objective of the "Entrepreneurship Development Conclave" and the manner in which it align with the Government's broader vision for fostering rural and grassroots entrepreneurship development, particularly in Maharashtra, including the Jalgaon Lok Sabha constituency;
- (b) the manner in which the Government proposes to leverage the Panchayati Raj system to implement skill development and capacity-building programmes for rural entrepreneurs, especially in the context of the conclave's discussions with a focus on addressing the unique challenges faced by entrepreneurs in Maharashtra;
- (c) whether any specific measures being taken by the Government to empower rural entrepreneurs to thrive in villages and small towns, particularly in areas like Jalgaon Lok Sabha constituency, through enhanced support mechanisms under the Panchayati Raj system; and
- (d) the manner in which the Government intend to ensure that the discussions and outcomes of the conclave translate into actionable policies and initiatives benefiting rural entrepreneurs in Maharashtra?

ANSWER

(a) to (d) The Entrepreneurship Development Conclave 2025, themed "Empowering Entrepreneurs Transforming Livestock Economics", was held to create awareness about entrepreneurship schemes under the Department of Animal Husbandry and Dairying (DAHD) to explore further opportunities and to facilitate access to credit for rural entrepreneurs. The conclave was organised by DAHD. The event also showcased successful projects under the National Livestock Mission Entrepreneurship Development Programme (NLM-EDP) and Animal Husbandry Infrastructure Development Fund (AHIDF) while acknowledging the contributions of key stakeholders, including entrepreneurs, financial institutions and policy makers. By bringing together all stakeholders, the conclave facilitated the exchange of ideas and insights to strengthen these schemes, ensuring their long-term impact on rural economic growth.

The conclave aligned with the Government's broader vision of Viksit and Atma Nirbhar Bharat, contributing to job creation, financial inclusion, and the development of sustainable livestock infrastructure. With a particular emphasis on investment, dairy processing, feed infrastructure, and employment generation, the event was crucial for the upliftment of rural economies, especially in Maharashtra. The details of Maharashtra State, including Jalgaon, under National Livestock Mission Entrepreneurship Development Programme (NLM-EDP) and Animal Husbandry Infrastructure Development Fund (AHIDF) are placed at **Annexure**.

The Entrepreneurship Development conclave implemented by the Department of Animal Husbandry and Dairying envisaged breed up-gradation, enhancing production & productivity and focus was laid on Entrepreneurial activities which will be promoted through existing schemes.

Discussions were held as to how States/beneficiaries could avail benefits under NLM & AHIDF Schemes. Under NLM, the entrepreneurship activities related to sheep and goat poultry, pig, feed and fodder, camel, donkey, horse, are promoted for which the beneficiary can avail 50 % subsidy of upto Rs 50 Lakh from Central Government. Also, the benefits of AHIDF, which involves 3% interest subvention, 25% credit guarantee, loan upto 90% and easy online mechanism were explained to all the participants.

Technical discussions were also held stressing upon leveraging technology such as artificial insemination for improved productivity and the involvement of cooperatives/Private Sector for increased production and value addition to increase profitability in dairy. It was also discussed how affordable credit is made easily available to the farmers which would boost rural entrepreneurship and enhance economic resilience.
