PM-SGMBY IN NORTH EASTERN STATES

Will the Minister of NEW AND RENEWABLE ENERGY be pleased to state:

- (a) whether the Pradhan Mantri-Surya Ghar Muft Bijli Yojana (PM-SGMBY) has been implemented in the North Eastern States;
- (b) if so, the details thereof and if not, the reasons therefor;
- (c) the number of applications received from residents of the North Eastern States under the Yojana and the amount of subsidies provided thereunder, year-wise, State-wise and district-wise for Manipur; and
- (d) the number of rooftop solar installations in the State of Manipur, district-wise?

ANSWER

THE MINISTER OF STATE FOR NEW & RENEWABLE ENERGY AND POWER (SHRI SHRIPAD YESSO NAIK)

(a) to (d) The Ministry of New and Renewable Energy is implementing PM Surya Ghar: Muft Bijli Yojana (PMSG: MBY) across the country including the North Eastern states since February 2024. The scheme targets to achieve rooftop solar installations in one crore households in the residential sector by FY 2026-27 with an outlay of Rs 75,021 crore.

For individual households, the Central Financial Assistance (CFA) available under PMSG: MBY is Rs. 30,000/- per kWp for the first 2 kWp and Rs. 18,000/- per kWp for the additional one kWp. The subsidy is capped at 3 kWp rooftop solar plant capacity for individual household. For Group Housing Societies/ Residential Welfare Associations (GHS/RWA) the CFA is Rs. 18,000/- per kWp with rooftop solar plant capacity limit of 500 kWp.

In case of special category states/UTs including Uttarakhand, Himachal Pradesh, J&K, Ladakh, States in the North East Region, UTs of A&N and Lakshadweep, the CFA is 10% higher.

As on 19.03.2025, a total of 3.12 lakh applications has been received from the North Eastern states on the National Portal of the scheme. Further, a total of 10,689 households have been benefitted under the scheme by installation of rooftop solar plants and a total amount of Rs 55.51 crore has been disbursed as CFA to the North Eastern states under the scheme. The detail of North Eastern states is given in **Annexure I.** The district wise detail for the state of Manipur is given in **Annexure II.**
