SCHEMES IN UNDER DEVELOPED REGIONS

4418. SHRI CHAVDA VINOD LAKHAMSHI:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) whether the Government is aware that Bhuj, Abdasa, Gandhidham, Rapar, Mandvi and Anjar districts in the Kachchh Lok Sabha Constituency are comparatively less developed in terms of industrialization and employment generation in the secondary and tertiary sectors;
- (b) if so, whether the Government is implementing the Micro and Small Enterprises Cluster Development Programme (MSE-CDP), the Scheme of Fund for Regeneration of Traditional Industries (SFURTI) and the ASPIRE Scheme (A Scheme for Promotion of Innovation, Rural Industry and Entrepreneurship) in Bhuj, Abdasa, Gandhidham, Rapar, Mandvi and Anjar districts of the Kachchh Lok Sabha Constituency;
- (c) if so, the details of the status of the schemes/projects being implemented, outcomes achieved and execution timeline; and
- (d) if not, the reasons therefor?

ANSWER

MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SUSHRI SHOBHA KARANDLAJE)

- (a): Bhuj, Abdasa, Gandhidham, Rapar, Mandavi, and Anjar are the Part of Kachchh District, Gujarat. Details of MSME units registered under Udyam Registration Certificate (URC) in Kachchh District on 31st March 2022 was 24,397 with total employment of 1,73,525, which has increased to 1,13,561 units with total employment of 5,02,373 as on 15th March 2025. The details are mentioned in Annexure "A".
- (b) to (d): The Ministry of Micro, Small and Medium enterprises implement various schemes and programmes for the growth and development of MSME sector in country including the District of Kachchh of the State of Gujarat. These schemes / programmes including Micro and Small Enterprises Cluster Development Programme (MSE-CDP), the Scheme of Fund for Regeneration of Traditional Industries (SFURTI) and the ASPIRE Scheme (A Scheme for Promotion of Innovation, Rural Industry and Entrepreneurship). MSE-CDP, SFURTI and ASPIRE are demand driven schemes and no proposals under the said Schemes have been received for Bhuj, Abdasa, Gandhidham, Rapar, Mandvi and Anjar areas of the Kachchh Lok Sabha Constituency in the last three years.
