URBAN DEVELOPMENT AND HOUSING SCHEMES IN ODISHA

NO. 4446. SHRI ANANTA NAYAK:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the number of beneficiaries benefited under urban development and housing schemes in Odisha so far;
- (b) the number of benefits provided to tribal communities in Keonjhar district under Pradhan Mantri Awas Yojana- Urban (PMAY-U) and other urban development schemes;
- (c) the number of cities covered under AMRUT and Swachh Bharat Mission (SBM) in Odisha along with the progress made under these schemes in Keonjhar district;
- (d) the total funds allocated under Smart Cities Mission (SCM), water management, sewerage systems and sanitation schemes in Odisha along with the details of works carried out in Keonjhar district under these schemes; and
- (e) whether the Government proposes to implement any special housing and infrastructure schemes for tribal communities in Keonjhar district and if so, the details thereof?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI TOKHAN SAHU)

(a): As per the provisions of Article 243W of the Constitution, in conjunction with the Seventh and Twelfth Schedules, matters relating to urban development fall within the purview of States/Urban Local Bodies. However, Ministry of Housing and Urban Affairs (MoHUA) provides programmatic support to the State Governments/Union Territories (UTs) in their urban development agenda through its various flagship Missions/Programmes viz. Atal Mission for Rejuvenation and Urban Transformation (AMRUT & AMRUT 2.0), Pradhan Mantri Awas Yojana-Urban (PMAY-U & PMAY-U 2.0), Smart Cities Mission (SCM), Swachh Bharat Mission-Urban (SBM-U & SBM-U 2.0) etc. Central Assistance (CA) released to State Governments/UTs through these Missions. Under PMAY-U, 2,03,380 houses have been sanctioned in Odisha since inception, out of which 1,84,643 houses are grounded for construction and 1,58,659 houses has been completed.

- (b) & (e): In Keonjhar district of Odisha, 2797 houses were sanctioned under PMAY-U for tribal communities out of which 2526 houses have been grounded for construction since inception. Further, MoHUA has launched PMAY-U 2.0 'Housing for All' Mission with effect from 01.09.2024 to assist one crore additional eligible urban beneficiaries through four verticals i.e., Beneficiary Led Construction (BLC), Affordable Housing in Partnership (AHP), Affordable Rental Housing (ARH) and Interest Subsidy Scheme (ISS) across the country to construct, purchase & rent a house for eligible beneficiary at affordable cost.
- (c) & (d): AMRUT: In Odisha, 9 cities namely; Baleswar Town, Baripada Town, Bhadrak, Bhubaneswar Town, Brahmapur, Cuttack, Puri, Rourkela Town, and Sambalpur Town are covered under AMRUT. 191 projects have been taken up in Odisha under AMRUT for which ₹1,714.42 crore has been sanctioned which includes 130 water supply projects worth ₹1,535.57 crore and 13 sewerage/septage management projects worth ₹138.21 crore. Further, under AMRUT 2.0, 211 water supply projects worth ₹3,756.57 crore and 137 water body rejuvenation projects worth ₹184.31 crore have been approved in Odisha. No cities have been approved in Keonjhar district under AMRUT & AMRUT 2.0.

Under AMRUT, against Central share of ₹796.97 crore, ₹785.23 crore have been released. Under AMRUT 2.0, against Central share of ₹1,373 crore, ₹524.04 crore have been released/sanctioned.

SBM-U: SBM-U is uniformly implemented in all the urban areas of the country including Keonjhar district of Odisha for improvement of the sanitation, Solid Waste Management (SWM) and Used Water Management (UWM) infrastructure in the Cities for all the citizens including tribal communities. Funds are allocated/released to the States/Uts and not to districts. Details of funds allocated and released to Odisha is as below:

Under SBM-U, 1,65,925 unit of Individual Household Latrines (IHHLs) and 12,211 lakh Community Toilets/Public Toilets (CT/PTs) have been constructed. Out of 2,038 total wards, 2,037 ward are practicing door to door collection and 2,030 wards are practising source segregation. Out of the 1,823 tonnes per day (TPD) of waste, 1,759 TPD of waste is being processed.

Smart Cities Mission (SCM): Bhubaneswar and Rourkela in odisha were selected under the SCM in the State of Odisha. Total Central Assistance (CA) of ₹988 crore have been claimed i.e. ₹490 crore and ₹498 crore for Rourkela Smart City and Bhubaneswar Smart City respectively. In water, sanitation & hygiene sector, all 9 projects for Rs. 498 crores have been completed. Further, Keonjhar District is not covered under SCM.
