- (a) the details of the number of City Gas Distribution (CGD) projects set up in Tamil Nadu during the last five years and the current year;
- (b) the list of the companies that have taken up the said projects;
- (c) the progress made on these projects along with the timeline set for its completion;
- (d) the quantum of the funds disbursed thereon, year-wise;
- (e) whether any new project proposals have been received for setting up of CGD pipeline; and
- (f) if so, the details thereof and if not, the reasons therefor?

# MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SURESH GOPI)

(a) to (f) Providing Piped Natural Gas (PNG) connections and establishment of Compressed Natural Gas (CNG) stations is part of development of City Gas Distribution (CGD) Networks and the same is carried out by the entities authorized by Petroleum and Natural Gas Regulatory Board (PNGRB) as per their Minimum Work Programme (MWP).

After completion of 12/12A CGD bidding round, PNGRB has authorized entities for the development of CGD network in 307 Geographical Areas (GAs), covering almost 100% of the mainland area for the development of CGD network across the countryincluding 18 GAs in state of Tamil Nadu (including 1 GA spread over Andhra Pradesh, Karnataka & Tamil Nadu and 1 GA spread over Puducherry& Tamil Nadu). As per MWP, authorised entities have to establish 2,825 CNG stations and 2.3 crore PNG connections in the state of Tamil Nadu by 2032 (including 1 GA spread over Andhra Pradesh, Karnataka & Tamil Nadu and 1 GA spread over Puducherry& Tamil Nadu).

The progress of CGD in GAs comprising Tamil Nadu since 2018 upto31.01.2025 is 426 CNG stations and 78220 PNG connections. The GA wise CGD progress in TamilNadu, as on 31.01.2025 is at Annexure.

No fund is released by the Government for CGD projects. The project cost for CGD projects are borne by the concerned CGD entities as per their MWP and techno-commercial feasibility.
