## GOVERNMENT OF INDIA MINISTRY OF HOUSING AND URBAN AFFAIRS LOK SABHA UNSTARRED QUESTION NO. 4589 TO BE ANSWERED ON MARCH 27, 2025

### STATUS OF PROJECTS UNDER SCM

### NO. 4589. SHRI SUDHAKAR SINGH:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the details and the current status of the projects sanctioned under the Smart Cities Mission (SCM) along with the number of projects completed so far;
- (b) the details of the total number of projects along with the funds allocated and the utilization percentage under the said mission, smart city-wise;
- (c) whether there are significant delays in project execution and if so, the reasons therefor along with the steps taken/being taken by the Government to address them;
- (d) the current progress of the said projects in Bihar, particularly in Patna, Muzaffarpur and Bhagalpur;
- (e) whether the said cities of Bihar have received sufficient funding and technical support to meet their objectives under SCM and if so, the details thereof; and
- (f) whether the Government has conducted any impact assessment to evaluate the success of the mission and if so, the key findings thereof, particularly in States like Bihar where urban infrastructure challenges persist?

#### ANSWER

## THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI TOKHAN SAHU)

(a) & (b) Under Smart Cities Mission (SCM), 100 cities have undertaken a total of 8,063 projects amounting to ₹1,64,545 crore. As on 04.03.2025, 7,504 projects (i.e. 93% of total projects) amounting to ₹1,50,306 crore have been completed, as per the data provided by 100 Smart Cities.

The Central Government has a total outlay of ₹48,000 crore for the 100 cities under SCM. As on 04.03.2025, the cities have been able to claim central financial assistance of ₹47,538 crore (i.e. 99% of the total Central share allocation) as per the utilization of funds provided by them. The States/Union Territories are reported to have utilized ₹45,772 crore (i.e. 96% of the total Central share released).

Details of city wise status of projects, central financial assistance claimed and its utilization percentage are at Annexure-I.

(c) to (e) As apprised by the cities covered under SCM, the challenges encountered in implementing projects include, inter alia, legal issues, delay in obtaining clearances from different departments, land acquisition, construction in hilly areas, challenges in vendor and resource availability in small & medium cities, centralization of decision making in few cities, utilization of full capacity of ICCCs with integration of all municipal departments and agencies, frequent changing and dropping of projects.

4 cities *viz.* Bhagalpur, Biharsharif, Muzaffarpur and Patna selected under SCM from State of Bihar have completed 126 projects (83% of total projects) amounting to ₹4,211 crore, details of which are at Annexure-II. As on 04.03.2025, all the 4 cities of Bihar have been able to claim central financial assistance amounting to ₹1,735 crore.

Ministry of Housing and Urban Affairs (MoHUA) has a multi-level review structure to expedite the progress of projects under the SCM. At the National level, implementation is monitored by an Apex Committee headed by Secretary, MoHUA. At the State level, Mission implementation is monitored by the State level High Powered Steering Committee (HPSC) chaired by the Chief Secretary. At the City level, there is a provision for establishing Smart City Advisory Forum (SCAF) for all 100 smart cities to advise and enable collaboration among various stakeholders.

(f) A mid-term evaluation study was undertaken by 'Niti Aayog' for 'Evaluation of Centrally Sponsored Schemes in Urban Transformation Sector'. As part of the study, Smart Cities Mission (SCM) was evaluated and the report was published in February 2021.
