Will the Minister of AYUSH be pleased to state:

(a) the details of AYUSH Super Specialists hospitals/Arogya Kendras approved so far under National AYUSH Mission (NAM) in the State of Maharashtra, district-wise;

(b) the details of the funds sanctioned, allocated and utilised so far for these hospitals under this mission in the said State;

(c) the details of current status including targets fixed under National AYUSH Mission especially in Latur and Sambhaji Nagar districts of Maharashtra; and

(d) the steps being taken by the Government to achieve these targets on time?

#### ANSWER

## THE MINISTER OF STATE (IC) OF THE MINISTRY OF AYUSH (SHRI PRATAPRAO JADHAV)

(a) & (b) Public Health being a State subject establishment of AYUSH super speciality hospitals and Arogya Kendras in the State of Maharashtra comes under the purview of the respective State Government. However, under Centrally Sponsored Scheme of the National Ayush Mission (NAM), there is provision of financial assistance to the State Government for the establishment of 50/30/10 bedded Integrated Ayush Hospitals and accordingly as per the proposals received from State Government of Maharashtra through State Annual Action Plans (SAAPs), the Ministry of Ayush has approved 09 Integrated Ayush Hospitals(IAH).

The District-wise details of funds sanctioned/allocated and utilized for these approved IAH in Maharashtra is enclosed as **Annexure**.

(c). Since, implementation of NAM Scheme comes under the purview of respective State Government and accordingly no targets has been fixed by Government of India under NAM for Latur and Sambhaji Nagar districts of Maharashtra.
