Will the **Minister of HEALTH AND FAMILY WELFARE** be pleased to state:

(a) whether all the eligible beneficiaries under Ayushman Bharat Yojana have been covered cent-percent under the said scheme in Uttar Pradesh, district-wise including aspiring districts of Shravasti and Balrampur Parliamentary Constituency;

(b) if so, the details thereof; and

(c) the details of pending applications under Ayushman Bharat Yojana in the same State, district-wise including aspiring districts of Shravasti and Balrampur?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI PRATAPRAO JADHAV)

(a) to (c): Ayushman Bharat - Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) is an entitlement-based scheme and all the eligible beneficiary families are covered from day one of the implementation of the scheme in the State/UT. District-wise details of eligible individual beneficiaries in Uttar Pradesh are at **Annexure**.

Ayushman card creation is a continuous process. As per the existing guidelines of AB-PMJAY, Ayushman cards are created only after successful e-KYC through Aadhaar and matching of Aadhaar details with the details provided by the respective State. In cases of mismatch, Ayushman cards are created after manual scrutiny by the respective State Health Agency.
