- (a) the details of the action taken by the Coordination Committee for affirmative action in the private sector since its inception in 2006;
- (b) whether the Government has directed to the Apex Industry Associations for consideration of affirmative action, if so, the details thereof and if not, the reasons therefor:
- (c) the details of the job provided to the SCs/STs by the Apex Industry Association in outsourcing/contractual employment along with the monitoring mechanism put in place for the same; and
- (d) whether it is a fact that employment of SCs/STs in the outsource/contractual jobs is very meagre due to lack of monitoring affirmative action and if so, the details thereof?

ANSWER

(a) to (d): The Coordination Committee for Affirmative Action for SC/ST in the Private Sector was set up by the Government in 2006. So far, 9 meetings of Coordination Committee have been held. In the 1st Coordination Committee meeting, it was stated that the best course for achieving progress on the issue of affirmative action is through voluntary action by the industry itself. Accordingly, the Apex Industry Associations namely Confederation of Indian Industry (CII), Federation of Indian Chamber of Commerce and Industry (FICCI), Associated Chambers of Commerce & Industry (DICCI) have prepared Voluntary Code of Conduct (VCC) for their member companies centered around education, employability and entrepreneurship and employment to achieve inclusion.

Measures undertaken by the members of Industry Associations include scholarships, vocational training, entrepreneurship development programmes, coaching etc. The last updated information on Affirmative Action for SC/ST as received by the apex Industry Associations i.e. CII, FICCI, ASSOCHAM and DICCI, is Annexed.
