# ASSESSMENT OF PKVY

4910. SHRI SUDAMA PRASAD:

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

(a) the details of beneficiaries under the Paramparagat Krishi Vikas Yojana (PKVY), Statewise;

(b) the list of beneficiaries under the Pradhan Mantri Krishi Sinchayee Yojana (PMKSY), State-wise;

(c) the total amount sanctioned under the above said schemes; and

(d) whether the Government has conducted any assessment of the above said Schemes, if so, the details thereof?

#### ANSWER

THE MINISTER OF STATE FOR AGRICULTURE AND FARMERS WELFARE

कृषि एवं किसान कल्याण राज्य मंत्री (SHRI RAMNATH THAKUR)

(a): Government has been promoting organic farming through Paramparagat Krishi Vikas Yojana (PKVY) in all the States/UTs except north eastern. In North eastern states Mission Organic Value Chain Development for North Eastern Region (MOVCDNER) is promoting organic farming. Both the schemes stress on end-to-end support to farmers engaged in organic farming i.e. from production to processing, certification and marketing and post-harvest management. The primary focus of the schemes is to form organic clusters in a cluster where preference is given to small and marginal farmers to help them to create a supply chain.

So far, 25.30 lakh farmers have been benefited under the Paramparagat Krishi Vikas Yojana (PKVY) scheme, the State-wise details is given at **Annexure-I**.

(b): PMKSY is an umbrella scheme, consisting of two major components being implemented by the Department of Water Resources, River Development & Ganga Rejuvenation, Ministry of Jal Shakti, namely Accelerated Irrigation Benefit Programme (AIBP), and Har Khet Ko Pani (HKKP). HKKP, in turn, consists of four sub-components: (i) Command Area Development & Water Management (CAD&WM); (ii) Surface Minor Irrigation (SMI); (iii) Repair, Renovation and Restoration (RRR) of Water Bodies; and (iv)

Ground Water (GW) Development. State wise details of estimated number of target beneficiaries from PMKSY-AIBP and CADWM is given at **Annexure-II**.

Department of Land resources implementing Integrated Watershed Management Programme (WMP) since 2009-10, which was amalgamated as the Watershed Development Component of PMKSY (WDC-PMKSY) in 2015-16. The continuation of WDC-PMKSY has been allowed by the Government on 15.12.2021 as 'WDC-PMKSY 2.0' for the project has been revised 2021-2026 with a physical target of 49.50 lakh ha and indicative Central financial outlay of Rs. 8,134 crore. State-wise details of farmers benefited is given at **Annexure-III**.

(c): Since 2015-16 (As on 27.03.25) Rs.2337.96 crore funds has been released under the PKVY. Rs.18075 crore has been released as central assistance under PMKSY-AIBP and Rs.3129 crore has been released for CADWM works since April, 2016. For WDC-PKSY – 1.0 and WDC-PKSY, 2.0 components of PMKSY, Rs.19926.687 Crore and Rs.4674.85 Crore have been released respectively.

(d): Assessment of the PKVY scheme was conducted by NITI Aayog in February 2020. The evaluation found that the scheme is highly relevant for the development of agriculture sector and is in-line with future requirements for sustainable growth.

Development Monitoring and Evaluation Office (DMEO) under NITI Ayog has carried out evaluation of PMKSY for the period 2015-2020. Most components of PMKSY have been ranked as satisfactory in terms of relevance, efficiency, impact and equity parameters of the performance.
