## Technical and Financial Assistance under JJM to Harvana

†494. Shri Satpal Brahamchari:

Will the Minister of JAL SHAKTI be pleased to State:

- (a) the details of the technical and financial assistance provided by the Government in Haryana, especially in the Sonipat Parliamentary Constituency under the Jal Jeevan Mission (JJM) during the last three years and the current year, district-wise;
- (b) the steps taken / being taken by the Government for timely completion of the pending projects under the JJM;
- (c) whether the Government has made any assessment of the reasons for delay in the said projects and if so, the details thereof; and
- (d) whether the Government has set any specific timeline for the completion of the said projects and if so, the details thereof?

## **ANSWER**

MINISTER OF STATE FOR JAL SHAKTI (SHRI V. SOMANNA)

(a) & (b): Since August 2019, Government of India in partnership with States is implementing Jal Jeevan Mission (JJM) – Har Ghar Jal to make provision of potable water to every rural household of the country, through functional tap water connection i.e. at a service level of 55 litre per capita per day (lpcd), of prescribed quality (BIS:10500), on regular and long-term basis.

As reported by the State Government of Haryana, as on 03.02.2025, all 30.41 Lakh (100%) rural households in Haryana have been provided with tap water connection, of which about 12.75 lakh connections have been provided under Jal Jeevan Mission. Similarly, in Sonipat district of Haryana, all 2.05 Lakhs rural households have been provided tap water connections, out of which, around 86 thousand tap connections have been provided under JJM.

To expedite the planning and implementation, as well as monitoring and handhold States/ UTs including Haryana, Government of India has taken number of steps which *inter alia* discussion and finalization of annual action plan (AAP) in consultation with States/ UTs, regular review of planning and implementation, workshops/ conferences/ webinars for capacity building and knowledge sharing, field visits by multi-disciplinary team to provide technical support, etc. To bring transparency and effective monitoring, an online 'JJM dashboard' has been created, which provides State/ UT, district and village-wise progress as well as status of provision of tap water supply to rural homes.

The year-wise details of funds allocated, released and utilized by Haryana for drinking water supply in rural areas under Jal Jeevan Mission (JJM) are as under.
