INCENTIVES TO STATES GENERATING SURPLUS NEW AND RENEWABLE ENERGY

5066. SHRI MURASOLI S

Will the Minister of NEW AND RENEWABLE ENERGY be pleased to state:

- (a) whether the Government has incentivized the States which are generating surplus new and renewable energy in the country;
- (b) if so, the details thereof and if not, the reasons therefor;
- (c) the details of the new and renewable energy generation capacity installed and generated in various States along with the surplus renewable energy generating States in the country; and
- (d) the funds allocated and disbursed to various new and renewable energy power surplus generation States during the last five years, project-wise?

ANSWER

THE MINISTER OF STATE FOR NEW & RENEWABLE ENERGY AND POWER (SHRI SHRIPAD YESSO NAIK)

- (a) & (b) At present there is no specific provision to incentivise states for generating surplus new and renewable energy in the country. However, the Ministry of New and Renewable Energy (MNRE) is implementing various schemes and programmes, which are mostly demand driven, providing financial support and incentives for installation of renewable energy projects by states/UTs. The states/UTs can avail financial support and incentives through participation in these schemes and programmes. Further, the economy of the home State where new and renewable energy plants are set up already gains by way of increased business, higher employment, and additional GST revenue.
- (c) The source-wise and state-wise renewable energy capacity installed in the country as on 28.2.2025 is given at **Annexure-I.**
- (d) Most of the schemes and programmes being implemented by MNRE are demand driven, and therefore, state-wise allocation is not made. The detail of funds released under various schemes and programme of the Ministry during last five years is given at **Annexure-II**.
