IMPLEMENTATION OF PMKVY 4.0

51. SHRI KRISHNA PRASAD TENNETI:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:-

(a) the details of total number of eligible candidates registered under the short-term training, special projects, and recognition of prior learning components of PMKVY 4.0 segregated into different skills, State and district-wise in Andhra Pradesh especially Bapatla Parliamentary Constituency (PC);

(b) the total number of trained candidates who have received regular employment following training, State and district-wise in Andhra Pradesh especially Bapatla PC;

(c) the target number of candidates to be trained under various components of PMKVY 4.0 along with the year of saturation; and

(d) the total financial outlay for the PMKVY 4.0 throughout its whole operational period along with utilisation?

ANSWER

THE MINISTER OF STATE (INDEPENDENT CHARGE) IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP

(SHRI JAYANT CHAUDHARY)

(a) The Ministry of Skill Development and Entrepreneurship is implementing Pradhan Mantri Kaushal Vikas Yojana 4.0 (PMKVY 4.0) since 2022-23, for imparting skill development training through Short-Term Training (STT) and up-skilling and re-skilling through Recognition of Prior Learning (RPL) to youth across the country including Andhra Pradesh. Special Projects are project-based short-term skilling initiatives that primarily meet the skilling needs of marginalized and vulnerable groups, difficult geographies and specialized training courses which are likely to be offered outside of regular short-term skilling programmes.

The district wise and job role wise number of candidates enrolled under Short-Term Training (STT), Recognition of Prior Learning (RPL) and Special Project component of PMKVY 4.0, as on 31.12.2024, in the State of Andhra Pradesh especially Bapatla Parliamentary Constituency (PC) is given at **Annexure I**, which are available on Ministry's website at <u>https://msde.gov.in/en/useful-links/parl-ques/loksabha</u>.

(b) Under PMKVY scheme, placements were tracked in the Short-Term Training (STT) component in the first three versions of the Scheme which is PMKVY 1.0, PMKVY 2.0 and PMKVY 3.0 implemented from FY 2015-16 to FY 2021-22. Under PMKVY 4.0, the focus is to empower our trained candidates to choose their varied career path and they are suitably oriented for the same. The district wise number of candidates trained and reported placed under PMKVY 1.0 to 3.0 in the State of Andhra Pradesh is given at **Annexure II**.

(c) & (d) PMKVY 4.0 has been designed as a Demand-Driven scheme to skill 1.5 crore candidates through Short-Term Training (STT) including Special Projects (SP) and Recognition of Prior Learning (RPL) for a period of four years from 2022-23 to 2025-26 with an outlay of ₹6,000 crore. ₹ 1,244.52 crore has been utilized under PMKVY 4.0 till date.
