PM-VISHWAKARMA SCHEME IN ASSAM

527. SHRI GAURAV GOGOI:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the details of artisans enrolled in PM-Vishwakarma Scheme since its launch in Assam, district-wise;
- (b) whether the Government is offering specific skill development programmes to the artisans, if so, the details thereof;
- (c) whether the Government has mechanisms in place to monitor the scheme's implementation and evaluate its impact on the livelihoods of the artisans, if so, the details thereof; and
- (d) whether the Government has undertaken any initiatives to create awareness about the scheme amongst artisans, especially those situated in remote and inaccessible areas, if so, the details thereof?

ANSWER

MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SUSHRI SHOBHA KARANDLAJE)

- (a): The PM Vishwakarma Scheme was launched on 17.09.2023 to provide end-to-end support to artisans and craftspeople of 18 trades who work with their hands and tools. The details of district-wise applications received and the number of applications which have successfully registered, after the 3-stage verification, under the Scheme from the State of Assam, since the launch of the Scheme on 17.09.2023 upto 31.01.2025 are at **Annexure.**
- (b): Under the skill component of the Scheme, beneficiaries are given Basic Training of 5–7 days and Advanced Training of 15 days free of cost. During the training period, beneficiaries are paid a stipend of Rs.500 per day as wage compensation, along with travel expenses of Rs.1,000.
- (c): At the National level, the implementation of the Scheme is monitored through regular meetings of the National Steering Committee (NSC), which is chaired by the Secretary, Department of Financial Services (DFS), Secretary, Ministry of Skill Development and Entrepreneurship (MSDE), and Secretary, Ministry of Micro, Small and Medium Enterprises (MSME).
- (d): Under the Scheme, various outreach programmes, trade fairs and State-level exhibitions are organized across the country to spread awareness about the benefits of the Scheme, with funding from the Government of India. These initiatives aim to reach artisans, including those in remote and inaccessible areas.
