FLOOD MANAGEMENT AND ANTI-EROSION WORK IN ANDHRA PRADESH

5371. SHRI G M HARISH BALAYOGI

Will the Minister of **JAL SHAKTI** be pleased to state:

- (a) whether the Government is providing financial, technical and other support including grantin-aid to States/UTs for flood management and anti-erosion works, especially for Konaseema district in Andhra Pradesh;
- (b) if so, the details thereof including the schemes under which the funds are allocated;
- (c) the details of the anti-erosion works undertaken in the Konaseema district during the last three years;
- (d) the details of the number of proposals received and approved for flood control and management during the last five years, State-wise, especially in the Godavari basin;
- (e) the details of the funds sanctioned, released and utilized along with the number of works undertaken for the same during the last three years, year and State-wise, particularly in Konaseema district of Andhra Pradesh; and
- (f) the steps taken/being taken by the Government to improve river basin management and increase the flood-bearing capacity of the Godavari River, especially in the delta region?

ANSWER

(a) to (f) Flood management and anti-erosion schemes are formulated and implemented by concerned State Governments as per their priority. The Union Government supplements the efforts of the States by providing technical guidance and promotional, financial assistance for management of floods in critical areas. To strengthen the structural measures of flood management, Ministry had implemented Flood Management Programme (FMP) during XI & XII Plan for providing Central Assistance to States for works related to river management, flood control, anti-erosion, drainage development, anti-sea erosion, etc. which subsequently continued as a component of "Flood Management and Border Areas Programme" (FMBAP) for the period from 2017-18 to 2020-21 and further extended up to March, 2026.

No flood management projects of Andhra Pradesh have been received for inclusion under FMBAP Scheme.

There are no works undertaken for anti-erosion in Konaseema district during the last three years.

The Government of Andhra Pradesh have allocated funds under the Action plan of O&M Works. Statement regarding list of proposals received and approved for Flood Materials, over the last five yeas in the jurisdiction of Chief Engineer, Godavari Delta System, Dowlaiswaram is annexed at **Annexure-I**.

The Government of Andhra Pradesh have accorded Administrative Approval of Rs. 548.32 Crores for "Raising and widening of Godavari Flood Banks to 1986 standards along with repairs to structures, construction of new structures, formation of ramps and groynes" and the works have been completed.
