ZERO DEFECT ZERO EFFECT

5380. DR. BYREDDY SHABARI:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to State:

(a) the number of Micro, Small and Medium Enterprises (MSMEs) that have received Zero Defect Zero Effect (ZED) certification during the last five years, State and year-wise;

(b) the number of MSMEs in Andhra Pradesh that have obtained Bronze, Silver, Gold, Diamond and Platinum Certification, district wise;

(c) the total funds allocated, sanctioned and utilized for promoting ZED certification across States, yearwise;

(d) the number of MSMEs that have applied for ZED certification but are pending for approval, State-wise and district-wise for Andhra Pradesh; and

(e) whether the Government has conducted any assessment on the impact of ZED certification on MSME competitiveness, exports and sustainability and if so, the key findings thereof?

ANSWER

MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SUSHRI SHOBHA KARANDLAJE)

(a): The MSME Sustainable (ZED) Certification Scheme was launched on 28.04.2022. The number of Micro, Small and Medium Enterprises (MSMEs) that have obtained Zero Defect Zero Effect (ZED) certification since its launch are 2,83,515 as on 28.03.2025. State-wise and year-wise details are at Annexure-I.

(b): The revised ZED Scheme i.e., the MSME Sustainable (ZED) Certification Scheme has only three levels of Certification i.e., Bronze, Silver and Gold. The district wise details of MSMEs certified in the State of Andhra Pradesh are at **Annexure-II**.

(c): MSME Sustainable (ZED) Certification Scheme is a Central Sector Scheme. The total year wise funds allocated, sanctioned and utilized for MSME Sustainable (ZED) Certification Scheme under MSME Champions Scheme and MSME Champions RAMP (Raising and Accelerating MSME Performance)-EAP is tabulated below:

(d): The number of MSMEs that have applied for ZED certification but are pending for approval is Zero.

(e): The ZED Certification Scheme promotes Zero Defect Zero Effect (ZED) practices, encouraging MSMEs to adopt quality manufacturing with minimal environmental impact. The Government has not conducted any third-party impact assessment on the ZED Certification Scheme. However, internal evaluations indicate that the ZED Certification Scheme has been able to improve awareness on quality, environment, safety, cleanliness and hygiene, and has also contributed to reduction in defects and rejections.
