NO. 5462. SHRI APPALANAIDU KALISSETTI:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the details of the projects approved under City Investments to Innovate, Integrate and Sustain (CITIIS) 1.0 and CITIIS 2.0, city and State-wise;**
- (b) the details of the total funds allocated, sanctioned and utilized under both phases of the scheme along with a breakdown of loans and grants from international partners;**
- (c) the current status of the implementation of each project under CITIIS 1.0 and 2.0 including expected completion timelines and delays, if any;**
- (d) the number and details of proposals pending for approval along with the reasons for the delay and the expected timeline for clearance;**
- (e) the criteria used for selection of cities and projects under CITIIS 2.0;**
- (f) whether any new cities would be included in the future and if so, the details thereof; and**
- (g) whether the Government proposes to expand the scope of CITIIS beyond smart cities and provide additional funding support to smaller urban areas and if so, the details thereof?**

ANSWER

- (a) 12 cities were selected under the City Investments to Innovate, Integrate and Sustain (CITIIS) 1.0 program across the country.**

CITIIS 2.0 program was launched on 31.05.2023 for envisaging comprehensive support to the competitively selected projects promoting circular economy with focus on integrated waste management at the city level, climate-oriented reform actions at the State level, and institutional strengthening and knowledge dissemination at the National level.

Under CITIIS 2.0, 18 cities under Component 1 (at city-level action) and 21 States under component-2 (at State level action) were selected.

Details of the projects approved under CITIIS 1.0 and CITIIS 2.0 under component-1 and component-2 are at Annexure-I, Annexure-II and Annexure III.

- (b) & (c) Under CITIIS 1.0, ₹ 771.99 crore have been allocated, out of which, ₹753.48 crore have been released to the cities and ₹662.88 crore have been utilized so far. Under CITIIS 1.0, the projects in Amritsar, Bhubaneswar, Dehradun, Kochi, Surat and Visakhapatnam have been completed. The projects in Agartala, Amaravati, Chennai, Hubballi-Dharwad, Puducherry and Ujjain are ongoing.**

Under the CITIIS 2.0 program, the project agreements with cities and States have been signed on 03rd March 2025. Under CITIIS 2.0, ₹1920 crore have been allocated, out of which ₹84.5 crore have been released, detail of which are at Annexure-IV.

- (d) & (e) All 100 Cities selected under the Smart Cities Mission were eligible to apply for the CITIIS 2.0 challenge. 84 cities submitted their proposals, out of which 18 cities were selected through the criteria stipulated in the CITIIS Operational Guidelines.**

- (g) Government of India has approved the CITIIS 2.0 up to 31.12.2027.**
