Will the **Minister of HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the funds allocated/utilized under Janani Suraksha Yojana during the last five years by the State Governments, State/UT-wise particularly Maharashtra;
- (b) the number of institutional deliveries recorded in the country under the said scheme during the said period;
- (c) the ranking of various States in this regard;
- (d) whether there is any provision for providing cash assistance to all Below Poverty Line (BPL)/SC/ST women coming for institutional delivery in Government and private hospitals under Janani Suraksha Yojana of National Health Mission (NHM);
- (e) if so, the details thereof; and
- (f) the details of amount of cash assistance provided for this purpose in various villages/rural and urban areas, State/UT-wise particularly in Maharashtra?

ANSWER

(a): Under National Health Mission (NHM), the State/UT-wise details of expenditure reported by the States/UTs under JSY during the last five years including Maharashtra is placed at Annexure-I.

(b) and (c): The number of institutional deliveries (number of JSY Beneficiaries) under the scheme in the country are given in the table below. The State-wise details of total institutional deliveries as per NFHS-5 (2019-21) is placed at Annexure-II.

(d) to (f): Janani Suraksha Yojana (JSY) implemented under the National Health Mission (NHM) is a safe motherhood intervention promoting institutional delivery among all pregnant women including women from weak socio-economic status i.e. women from Scheduled Castes, Scheduled Tribes and BPL households. The details of eligibility and cash assistance under JSY in rural and urban areas for States/UTs including Maharashtra (High Performing States (HPS)) is as follows:

Low Performing States (LPS)*	1400	1000	Available to all women regardless of age and number of children for delivery in government/private accredited health facilities.
High Performing States (HPS)**	700	600	Available only to BPL/SC/ST women regardless of age and number of children for delivery in government/ private accredited health facilities.
Financial Assistance for Home Delivery			
Low Performing States (LPS)*	500	500	Available only to BPL women (regardless of age and number of children) who prefer to deliver at home.
High Performing States (HPS)**	500	500	

* Low Performing States (LPS) are the States/UTs which have low institutional delivery rates, namely, Assam, Bihar, Chhattisgarh, Jharkhand, Jammu & Kashmir, Ladakh, Madhya Pradesh, Odisha, Rajasthan, Uttar Pradesh and Uttarakhand.

** High Performing States (HPS) are the remaining States/UTs where the levels of institutional delivery are satisfactory.
