RIISING CASES OF DEATHS DUE TO NON-COMMUNICABLE DISEASES

5673. SHRI RAO RAJENDRA SINGH:

Will the **Minister of HEALTH AND FAMILY WELFARE** be pleased to state:

(a) whether there is any dedicated share of fund that is allocated to the National Programme for Prevention and Control of Non-Communicable Diseases (NP-NCD) under the National Health Mission (NHM) in view of the rising share of unnatural deaths due to Non-Communicable Diseases in the country and if so, the details thereof; and

(b) whether the Government has any data on the number of NCD Cells and Clinics, Cardiac Care Units for emergency cardiac care and 64 Day-Care Centres for Cancer care functioning within the ambit of the NP-NCD and if so, the details thereof?

(a) & (b) The Department of Health and Family Welfare provides technical and financial support to States and Union Territories across the country under the National Programme for Prevention and Control of Non-Communicable Diseases (NP-NCD) as part of the National Health Mission (NHM). The programme focuses on strengthening infrastructure, human resource development, screening, early diagnosis, referral, treatment, and health promotion for Non-Communicable Diseases (NCDs).

The funds are being provided to the States under NCD Flexi-Pool through State Programme Implementation Plan (PIPs) of respective States/UTs, with the Centre to State share in ratio of 60:40 (except for NE and Hilly States, where the share is 90:10). Under the programme, 770 District NCD Clinics, 372 District Day Care Centres, and 6410 NCD Clinics at Community Health Centres have been set up. The details of funds released to States & Union Territories during last five years under the Programme is at Annexure.
