FOOD PROCESSING INDUSTRIES IN ODISHA

601. SMT. SANGEETA KUMARI SINGH DEO:

Will the Minister of ***FOOD PROCESSING INDUSTRIES*** be pleased to state:

- (a) the details of the steps taken/being taken by the Government to promote food processing industries in Odisha, particularly in tribal-dominated and backward districts during the last three financial years and the current year, year-wise;
- (b) the details of the number of food processing units set up in Odisha under the Pradhan Mantri Kisan Sampada Yojana (PMKSY) along with other relevant schemes during the said period; and
- (c) whether the Government has received any proposals for setting up of Mega Food Parks or Cold Chain projects from Odisha and if so, the details thereof?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES
(SHRI RAVNEET SINGH)

(a) In order to promote and ensure overall development in the food processing sector, Ministry of Food Processing Industries (MoFPI) has been incentivizing setting up/expansion of related infrastructure through its Central Sector Pradhan Mantri Kisan SAMPADA Yojana (PMKSY) Scheme, Production Linked Incentive Scheme for Food Processing Industry (PLISFPI) and Centrally Sponsored PM Formalization of Micro Food Processing Enterprises (PMFME) Scheme across the country including all districts of Odisha. These schemes are not region or state specific but demand driven. Under sub-schemes of PMKSY, MoFPI provides mostly credit linked financial assistance (capital subsidy) to entrepreneurs with total outlay of Rs.5520 crore for 15th Finance Commission Cycle. MoFPI also provides financial, technical and business support for setting up/ upgradation of micro food processing enterprises under PMFME scheme. The scheme is operational from 2020-21 to 2025-26 with total outlay of Rs.10,000 crores. PLISFPI is, inter alia, intended to support creation of global food manufacturing champions and support Indian brands of food products in international market. The Scheme is operational for a period from 2021-22 to 2026-27 with an outlay of Rs. 10,900 crores.

(b) & (c) MoFPI does not set up food processing units on its own. However, it incentivizes setting up of these Industries through its schemes. The details of approved projects under PMKSY, PMFME and PLISFPI since 2021-22 in Odisha is at **Annexure-I**. The details of approved Mega Food Parks and Cold Chain Projects under PMKSY Scheme since its inception in Odisha is at **Annexure-II**.
