- (a) the present status of the City Gas Distribution project;
- (b) the number of cities identified for the implementation of City Gas Distribution, the number of cities covered by the City Gas project and the number of households connected under this scheme, year-wise; and
- (c) whether Puducherry has been included in the City Gas Distribution scheme, if so, the details of the implementation of this work along with the present status in respect of Puducherry, Karaikal, Mahe and Yanam regions?

## MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SURESH GOPI)

(a) & (b) Providing Piped Natural Gas (PNG) connections and establishment of Compressed Natural Gas (CNG) stations are part of the development of City Gas Distribution (CGD) Network and the same is being carried out by the entities authorized by Petroleum and Natural Gas Regulatory Board (PNGRB) as per their Minimum Work Programme (MWP). After completion of 12/12A CGD bidding round, PNGRB has authorized entities for the development of CGD network in 307 Geographical Areas (GAs), including cities falling within the GA, covering almost 100% of the mainland area for the development of CGD network across the country. As on 30.11.2024, the authorized entities have established 7,395 CNG stations and provided 1.39 crore PNG (Domestic) connections across the country. The year-wise number of households connections in the country are as follows:
