Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the number of rural jobs created and rural enterprises established under the Prime Minister's Employment Generation Programme (PMEGP) in Maharashtra since its inception;
- (b) the key sectors that have benefited the most under PMEGP in terms of job creation;
- (c) the percentage of PMEGP beneficiaries in rural areas as women and those belonging to marginalized communities;
- (d) the initiatives undertaken to encourage their participation in the programme;
- (e) whether the Government conducted any impact assessment studies to evaluate the success of PMEGP in rural areas;
- (f) if so, the key findings of these studies, particularly with respect to employment generation and rural entrepreneurship;
- (g) the steps taken by the Government to ensure that beneficiaries under PMEGP receive adequate skill development and training for running successful enterprises; and
- (h) the number of loan applications under PMEGP that have been approved and disbursed by banks and financial institutions in rural areas during the last three years?

ANSWER

MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SUSHRI SHOBHA KARANDLAJE)

- (a): Since the inception of the Prime Minister's Employment Generation Programme in 2008-09, a total of 42,541 rural enterprises have been assisted under the Scheme in the State of Maharashtra generating employment to around 3,40,328 persons. Year-wise data is given at **Annexure I.**
- (b): The key sectors that have benefited the most under PMEGP in terms of job creation are Service & Textile, Agro-Based Food Processing, Rural Engg. & Bio-Tech, Mineral, Polymer & Chemical, Forest, Hand Made Paper & Fibre and Coir. Sector-wise details in terms of number of units assisted and estimated employment generated in the last 3 financial years and current FY 2024-25 (upto 01.02.2025) is given in **Annexure II**.
- (c): Details of percentage of women and beneficiaries from marginalized communities under the PMEGP Scheme for last 3 financial years and current FY2024-25 (upto 01.02.2025) is given at **Annexure III**.

- (d): The initiatives undertaken to encourage the participation of women and beneficiaries belonging to marginalized communities in the programme include:
 - i. Beneficiaries under Special Category including women and entrepreneurs from marginalized communities, i.e. SC, ST and OBC, are provided with higher subsidy of 25% and 35% of the project cost in urban and rural areas respectively as compared 15% and 25% of the project cost for General Category beneficiaries.
 - ii. Contribution of beneficiaries under Special Category including women and entrepreneurs from marginalized communities is 05% as compared to 10% for General Category beneficiaries.
 - iii. Conduct of awareness programmes in all the States/UTs including backward and underperforming areas, Aspirational districts, North Eastern Region, etc. with focus on special category.
 - iv. Conduct of two-days free online Entrepreneurship Development Programme (EDP) for prospective entrepreneurs.
 - v. Acceptance of PMEGP applications from prospective beneficiaries in 11 regional languages since January, 2024.
 - vi. Industries related to animal husbandry like dairy, poultry, aquaculture, insects (bees, sericulture, etc.) have been allowed under the scheme.
- (e) & (f): Ministry of MSME is implementing PMEGP since 2008-09 with Khadi and Village Industries Commission (KVIC) as nodal agency at the national level for generating employment opportunities in the country by setting up of micro- enterprises in the non-farm sector. KVIC has carried out a study through Indian Institute of Public Administration (IIPA) to analyze the impact of Covid-19 on employment generation on randomly selected 11126 PMEGP units assisted during 2017-18 to 2021-22 in rural as well as urban areas of the country. As per the study, the employment per unit in PMEGP units has increased from an average 9 persons per unit during 2021-22 to an average 11 per unit in the period 2023.
- (g): The steps taken by the Government to ensure that beneficiaries under PMEGP receive adequate skill development and training for running successful enterprises are as below:
 - i. Awareness programs are conducted in all the States/UTs including backward and underperforming areas, aspirational districts, Northeastern Region etc.
 - ii. Engagement of Marketing, Banking and Technical Experts in various KVIC offices to provide handholding support to the applicants in filling up the applications.
 - iii. A two-day free online Entrepreneurship Development Programme (EDP) for prospective entrepreneurs. KVIC has also developed a mobile app for online EDP and made it live, with effect from 22.10.2019.
 - iv. Webinars are organized on various activities for setting up of micro-enterprises on every Sunday for the awareness of youth and prospective entrepreneurs.
- (h): Number of loan applications under PMEGP that has been sanctioned, released and Margin Money disbursed in rural areas in last 3 years and current FY 2024-25 (upto 01.02.2025) is as below:
