MARKETING OF MILLET-BASED PRODUCTS

655. DR. D. PURANDESWARI: SHRI MUKESHKUMAR CHANDRAKAANT DALAL:

Will the Minister of *FOOD PROCESSING INDUSTRIES* be pleased to state:

- (a) the details of the key activities being implemented to promote millet-based products;
- (b) the details of the number of farmers and food processing units expected to be benefitted from the scheme;
- (c) the details of the fund spent/utilized out of the allocated amount of Rs. 800 crore so far;
- (d) the details of the policy initiatives undertaken by the Government to enhance the processing and marketing of millet-based products; and
- (e) whether the Government is taking any corrective measures to address the challenges faced during the implementation of the said scheme and if so, the details thereof?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI RAVNEET SINGH)

- (a) Ministry of Food Processing Industries (MoFPI) is implementing the Production Linked Incentive Scheme for the Food Processing Industry (PLISFPI) for a period from FY 2021-22 to FY 2026-27. One component of the scheme focuses on Millet-Based Products, with an outlay of Rs. 800 crores. This component was launched keeping in view International Year of Millets (IYOM). The objectives of the PLI Scheme for Millet-Based Products (PLISMBP) are to increase the use of millets in food products and promote their value addition by incentivizing the manufacturing and sale of selected millet-based products in both domestic and export markets.
- (b) 29 applicants have been approved under PLISMBP component of the scheme for millet-based units at 45 locations throughout the country. The details of these units are at **Annexure**. The number of farmers benefitted under this component is not maintained.
- (c) As on date, out of total allocation of Rs. 800 crores for PLISMBP, an amount of Rs.793.27 crore has been approved to incentivise 29 applicants. However, total amount of Rs.3.917 crore has been disbursed to 10 applicants so far.

- (d) Apart from incentivizing millets-based food processing units under PLISMBP, millet-based units are also eligible for availing benefits under other MoFPI's schemes like Pradhan Mantri Formalization of Micro Food Processing Enterprises (PMFME) and Pradhan Mantri Kisan Sampada Yojana (PMKSY). MoFPI hosted the third edition of 'World Food India' from 19th September to 22nd September, 2024 in New Delhi. With participation from numerous international exhibitors and this event provided a platform for the millets-based food industry to showcase products globally and promote millet-based products in international buyers. Further, the Agricultural & Processed Food Products Export Development Authority (APEDA), a statutory organization under the administrative control of the Department of Commerce, has the mandate to promote export of agricultural products, including millets, from India. APEDA provides assistance to its registered exporters, including those of millets, under Agriculture & Processed Food Export Promotion Scheme of APEDA. The assistance is provided under various components of the schemes viz. Infrastructure Development, Quality Development and Market Development.
- (e) As such, no challenge has been faced by the MoFPI in implementation of PLISMBP component of the scheme.
