657. SHRI LAVU SRI KRISHNA DEVARAYALU:

Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) the number of proposals received for setting up of multi-product food irradiation units under the Cold Chain Scheme of the Pradhan Mantri Kisan Sampada Yojana (PMKSY) as on the last date of submission;
- (b) the details of these proposals, including the States and sectors along with the number of proposals approved so far;
- (c) the details of the number of units established, made operational and under construction, State-wise, particularly in Andhra Pradesh; and
- (d) whether any proposals have been received from Andhra Pradesh, and if so, the details thereof including the current status and the financial assistance allocated to them?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI RAVNEET SINGH)

- (a) & (b) Expression of Interest (EoI) for submission of project proposals for setting up of Multi-product Food Irradiation Units under scheme for Integrated Cold Chain and Value Addition Infrastructure a component of Pradhan Mantri Kisan Sampada Yojana (PMKSY) was issued on 07.08.2024. Against this EoI, 17 no. of proposals were received. State-wise details of the same are at **Annexure-I.**
- (c) & (d) Prior to the EoI dated 07.08.2024, the Ministry had approved 16 food irradiation projects across the country under the scheme for Integrated Cold Chain and Value Addition Infrastructure. State-wise (including state of Andhra Pradesh) details of the same along with financial assistance and status are at **Annexure-II.**
