#### **Death of Endangered Olive Ridley Turtles**

#### 67. SHRI RAJA A:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) whether the Government is aware of the carcasses of endangered Olive Ridley Turtles reaching along the shores of Vizag Coast in Bay of Bengal, in recent months;
- (b) the details of the concern expressed by Marine Environment Experts on the issue;
- (c) whether any inquiry/study has been made in this regard, if so, the details thereof along with the reasons for death of turtles; and
- (d) the steps taken/proposed to be taken by the Government to prevent such incidents in future?

### **ANSWER**

- (a) to (d) As informed by the State Government of Andhra Pradesh, carcasses of Olive Ridley Turtles have been found along the shores of Vizag coast in Bay of Bengal. Enquiry made by the Andhra Pradesh Forest Department indicate entanglement of turtles in trawler nets as the main cause of death of turtles. However, such details are not maintained in the Ministry. The important steps taken by the Government for the conservation and protection of marine turtles include the following:
  - i. Five species of marine turtles viz., Olive ridley turtle (*Lepidochelys olivacea*), Green turtle (*Chelonia mydas*), Hawks bill turtle (*Eretmochelys imbricata*), Leatherback turtle (*Dermochelys coriacea*) and Loggerhead turtle (*Caretta caretta*) reported to be found in India are listed in Schedule I of the Wild Life (Protection) Act, 1972 thereby providing them the highest degree of protection.
  - ii. The Ministry provides financial and technical support to the States for conservation and management of wildlife including marine turtles and its habitat under the Centrally Sponsored Scheme- Development of Wildlife Habitats.
  - iii. The Ministry has included marine turtles as one of the 22 species for taking up focused conservation programme for recovery of critically endangered species under the Centrally Sponsored Scheme Development of Wildlife Habitats.

- iv. The Ministry through amendment of Wild Life (Protection) Act, 1972 during 2022 has empowered the India Coast Guard for entry, search and detention in case of any violations in relation to marine species listed in schedules of the Act, including marine turtles.
- v. The Ministry has released a National Marine Turtle Action Plan with the aim to conserve marine turtles and their habitats in India. The Action Plan focusses on reducing threats, conserving critical habitats, exchanging scientific data, increasing public awareness and emphasizes on a participatory approach in conservation of marine turtles and its habitat.
- vi. The Ministry has released 'Marine Megafauna Stranding Management Guidelines' in 2021 for management of stranding and entanglement of marine mega fauna including marine turtles.
- vii. A network of coastal and marine protected areas under the Wild Life (Protection) Act, 1972 has been created for the conservation of marine species, including turtles.
