CSR FUNDS SPENT IN RAJASTHAN

79. SHRI HARISH CHANDRA MEENA:

Will the Minister of CORPORATE AFFAIRS be pleased to state:

- (a) whether the Government has taken/proposes to take any steps to ensure the spending of funds under Corporate Social Responsibility (CSR) by various public sector banks in areas dominated by the most backward Scheduled Castes/Scheduled Tribes across the country; and
- (b) if so, the district/scheme-wise details of CSR funds spent in Rajasthan during the last five years?

- (a): Public Sector Banks (PSBs) are not incorporated under the Companies Act, 2013, and Corporate Social Responsibility (CSR) related provisions of the Companies Act, 2013, are not applicable to PSBs. However, PSBs undertake CSR related activities as per Reserve Bank of India's Guidelines and approved policy of their respective Boards in this regard. The CSR spending by PSBs includes expenditure on various activities spread across the country with multiple organisations supporting pan-India projects, such as Swachh Bharat Kosh, National Sports Development Fund, Clean Ganga Fund, PM's National Relief Fund, etc.
- (b): The legal framework for Corporate Social Responsibility (CSR) has been provided under Section 135 of the Companies Act, 2013 ('Act'), Schedule VII of the Act and Companies (CSR Policy) Rules, 2014. The CSR framework is disclosure based and companies are required to file details of CSR activities annually in the MCA21 registry. On the basis of annual filings made by companies in the MCA 21 registry, the district-wise & sector-wise CSR expenditure in Rajasthan by all CSR mandated companies for the last five financial years (FY) i.e, 2018-19, 2019-20, 2020-21, 2021-22 and 2022-23 are attached at Annexure-I & Annexure-II respectively.
